



## A515 Lichfield Road, temporary lane closures and satellite compound set up

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

To maintain a safe area for construction staff, there will be a temporary lane closure controlled by 2 way traffic lights on the A515, Lichfield Road.

We will set up a working area, on a section of land in the Parish of Kings Bromley, on the A515, Lichfield Road. These works will be to prepare the access and set up for our satellite compound.

We will be creating an entrance to the satellite compound, putting in new kerbs and placing down a concrete slab base.

We will construct a haul road which will be used by our construction vehicles. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, constructions machinery and/or construction staff around the site. Haul roads are Balfour Beatty Vinci's preferred logistical transport link, as they reduce the number of vehicles interfering with the existing local road network and provide the greatest possible control over works activity.

### When will we undertake these works

The temporary lane closures will be in place from 12 July for 6 weeks, between 8:00am and 6:00pm.

The traffic lights will operational 24/7.
