



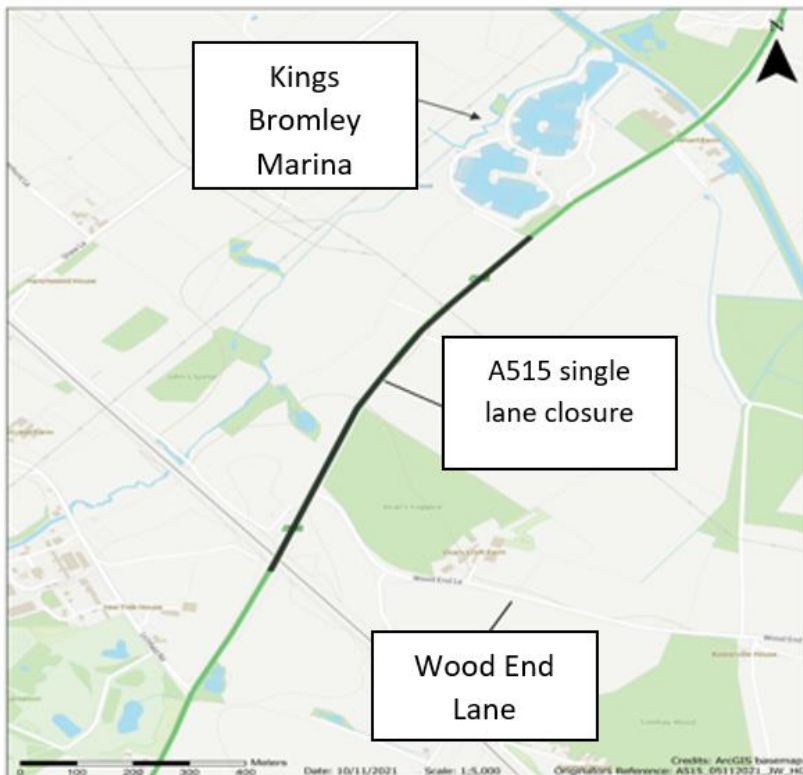
# Traffic management on A515, Kings Bromley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we are doing

From Thursday 9 December 2021 until Friday 17 December, we will be completing ground penetrating radar surveys to help us understand more about the ground conditions where we are building the railway. To enable to do this safely we will have a single lane closure with traffic lights on the A515. (see map below). The working hours will be from 9:30am to 3:30pm with an additional hour at the start and end of the working hours to set up and secure our equipment.
