To ensure that your state park experience is enjoyable, please be aware of the dynamic characteristics of the natural environment. There are some areas that may be potentially hazardous. All visitors should exercise caution when visiting any state park. Anyone who is unsure about possible hazards should contact a park ranger.

### Campground Rules and Regulations

1. Campers are allowed a maximum of one trailer/RV and one tent OR two tents per site. No more than six (6) persons (or one family) may occupy the same site. Limit 2 cars per site.
2. No more than 2 vehicles per site. Some sites are limited to one vehicle.
3. One site is designated for use by disabled persons.
4. Camping Check-in is 2 PM • **Check-out is 12 Noon.**
5. Cabin Check-In time: 4 PM • **Check-Out time: 10 AM**
6. Quiet hours are 10 PM - 7 AM.
7. Maximum length-of-stay on a particular site during periods of high demand is 14 nights.
8. Camping parties may not register for more than forty-two nights of any forty-nine consecutive night period (no more than twenty-eight nights out of sixty consecutive night period at parks located on US Army Corps of Engineers properties).
9. **Pets must be on a leash** (not longer than six feet) or under physically restrictive control at all times. Owners will be asked to remove noisy or dangerous pets or pets that threaten or harass wildlife.
10. **It is unlawful to dispose of any waste (including gray water) in places or receptacles other than those specifically designed for that purpose.**
11. All fires must be confined to designated grills or areas.
12. It is unlawful to cut, damage or remove plants, shrubs or trees.
13. **Possession of firearms is prohibited** inside of park facilities or buildings.
14. It is unlawful to possess or discharge fireworks or other explosives.
15. Only licensed vehicles may be operated in a state park and must remain in areas specifically intended for vehicular traffic.
16. Cancellations and changes are subject to fees based on the notice given. Changes are not permitted unless requested at least four days in advance for camping. Early departures are subject to cancellation policies. Transaction fees are non-refundable.
17. Registered campers may not change sites without permission from park staff.
18. **S.C. Citizens** (age 65 and older) and **S.C. disabled** residents may register for a campsite at a reduced rate. The qualifying individual must be present for the duration of the stay.
19. Visitors not registered for an overnight stay are required to pay the admission fee.
20. Roadside parking is prohibited. Do not park on unoccupied sites for any length of time.
21. **Alcoholic beverages are prohibited.**

Just a few miles off Interstate 77, centrally located between Columbia and Charlotte, Chester State Park rests in the quiet hills of the South Carolina Piedmont region and for generations has been a haven for hiking, picnicking and boating to the surrounding communities. The Civilian Conservation Corps built the park, and its work can still be seen and enjoyed today.



The park's 523 acres include a 160-acre lake, with a two-mile nature trail that follows along the shoreline up to the Civilian Conservation Corps-built stone spillway. Johnboat rentals are popular in the warmer months, and the park also offers a boat ramp for visitors with electric or hand-powered personal boats. Picnicking, rental picnic shelters, and a large playground system are located along the shoreline. Chester State Park also offers the first SC State Park tournament sanctioned Disc Golf Course. This 27 hole course has 3 loops suitable for professional, tournament play... with 18 of these holes having alternative tees for beginner/amateur level players. Lakeview Hall, a fully enclosed meeting facility overlooking the park lake, is regularly used for weddings, reunions, and corporate meetings. Boy Scouts, church groups and many other organized groups frequent the primitive group camping area throughout the year. Chester State Park's 25-site campground is open year round and has many sites that may accommodate anything from single tents to 40-foot RVs.

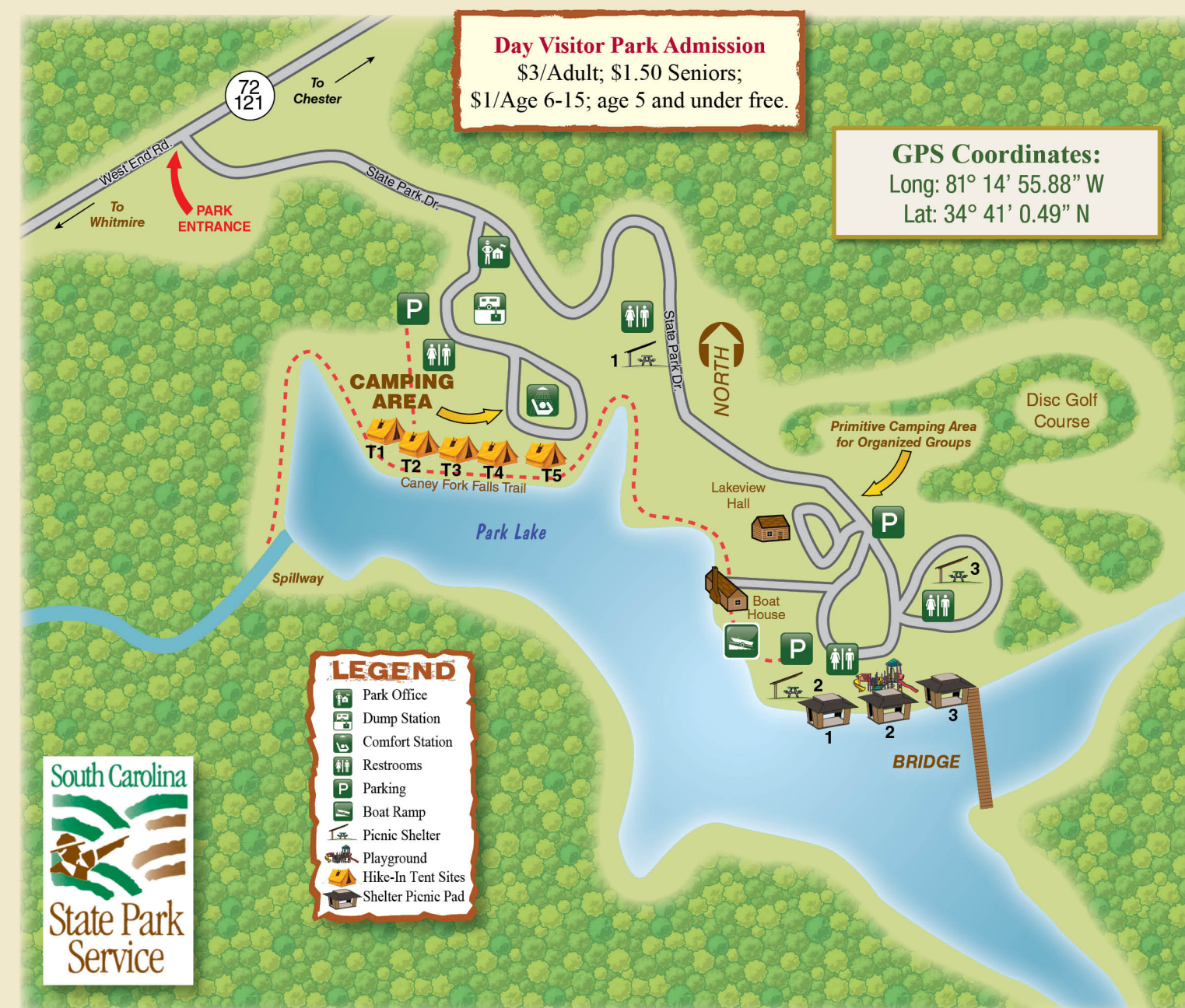
