MCV FIRE SUPPRESSION & OTHER PROTECTIVE COSTS BYLAW

A BYLAW OF THE TOWN OF NORQUAY, IN THE PROVINCE OF SASKATCHEWAN TO  
AUTHORIZE THE NORQUAY AND DISTRICT FIRE ASSOCIATION TO RECOVER MVC FIRE  
SUPPRESSION & OTHER PROTECTIVE COSTS

The Council of the Town of Norquay in the Province of Saskatchewan enacts as follows:

1) **SHORT TITLE**

This Bylaw may be cited as "The MCV Protective Cost Bylaw."

2) **PURPOSE**

This Bylaw addresses that the Norquay & District Fire Association is authorized to charge the applicable fees for all vehicle accidents, jaws of life services, vehicle fires, and fires caused by a vehicle occurring within the Town of Norquay limits for Town of Norquay Residents and Non-Residents.

3) **DEFINITIONS**

In this Bylaw:

- a) **"Council"** means the Mayor and Councillors of the town of Norquay elected pursuant to the provisions of *The Local Government Election Act, 2015*;
  - b) **"Municipality"** means the Town of Norquay;
  - c) **"Resident"** the place where someone lives within the boundaries of the Town of Norquay; it's their primary dwelling address within town, indicating that they are considered a resident of that particular area.
  - d) **"NON-Resident"** refers to a person who does not primarily live within the boundaries of the Town of Norquay, meaning they do not consider that town of Norquay their primary place of residence; they may live elsewhere and only occasionally visit the municipality.
- 4) The services will be charged to the insurer for all vehicle accidents, jaws of life services, vehicle fires, and fires caused by a vehicle occurring within the Town of Norquay limits, in accordance with the Schedule "A" fees set as per current SGI rate.
  - 5) The Norquay and District Fire Association is authorized to charge the various services, tests and emergency responses listed in Schedule "A" to the insurer using the SGI Vehicle Fire and Accident Claim Form as per the current SGI rate.
  - 6) The fees shall be reviewed and set by the Town of Norquay Council in pursuant with the SGI current emergency rates for Fire Suppression and Vehicle Extrication services fee and in consideration of the advice of the Fire Chief, as required.
