Spending is on track for 2025 and 2024 has been reconciled against Town GL a)

8. Coordinator's Report, Lisa Mills

- Street Banner Programme the Town has some unused funds that were a) earmarked the PEBIA and these could be used in several areas including the purchase of new brackets that would allow for larger banners
- b) **Public Art**: two of three installations are complete (murals at Ristorante Rosina, 613 Goderich), and the light installation (PORT letters) for Coulter Parkette should be in place by mid October
- c) **Unhoused** people at the Parkette - this is a much larger conversation to begin with the Town and the County Melissa Pettigrew has indicated that she has the daily chore of clearing up cigarette butts in front of her store
- d) Port Elgin Farmers' and Artisan Market - had a very successful second Season at the Green and Bricker location. Over 38,000 visitors this season. Shawna is working with Lisa and the Town for improvements and a small expansion for the 2026 season. Awaiting final vendor fees to reconcile the Season against budget.
