### REGISTER TO VOTE BY FRIDAY, 6TH FEBRUARY

A by-election for the position of a Conseiller in Chief Pleas will take place on Wednesday, 25th February. As in previous years, the polling station will be in the Toplis Room, Island Hall from 10am to 6pm. The by-election fills a vital vacancy and ensures strong representation for our island community.

**Who can participate?** If you have lived in Sark cumulatively for two years or more and are aged 16 years or over, you are eligible to register on the electoral roll and vote, and if aged 18 years or over, stand as a candidate.

**Deadline to register - Friday, 6th February:** Registration is quick and easy. Complete the form overleaf and return to the Greffe Office.
