# Death of Mr Arthur Rolfe, former Speaker of Chief Pleas – Condolences

# Numbering of Regulations at Midsummer Meeting – Statement by the Speaker

The Speaker: I just wish to make a short statement on the numbering of Regulations that I conducted at the Midsummer Meeting.

Since the Midsummer Meeting I have been informed from St James' Chambers that the Sark Emergency Regulation relating to the coronavirus pandemic was also laid before the States of Guernsey *before* our Meeting and was issued a number, no. 35/2020. Therefore the Regulation that was laid before you at the Easter Meeting on 22nd April and to which I allocated number I/2020 is superseded by the Guernsey no. 35/2020. It is academic for you, but it has to happen.

That also means that the Medical Practitioners Regulation needs to be re-numbered as number I/2020; I gave it the number II, as allocated at the Midsummer Meeting.

This is an issue which I take up with St James' Chambers to clarify for the future, because I can see confusion reigning, if Guernsey are going to be numbering Sark regulations which we in turn have laid before us and which we normally number at that stage. So that is something I shall take up for the future.

# Business of the Day

# 1. The Election of Conseillers 19th August 2020 – Policy and Finance Committee Report considered – Propositions carried

To consider a Report with Propositions from the Policy and Finance Committee entitled 'The Election of Conseillers 19th August 2020' and to approve the Ordinance entitled 'The Reform (Election of Conseillers (By-Election) (Sark) (No. 2) Ordinance, 2020'.

#### Proposition 1:

That Chief Pleas rescind proposition 2 on Agenda item 14 brought before Midsummer Chief Pleas 8th July 2020.

#### Proposition 2:

That Chief Pleas approve the Ordinance entitled The Reform (Election of Conseillers) (By-Election) (Sark) (No. 2) Ordinance, 2020.

The Speaker: We only have a single Agenda item: to consider a Report with Propositions from the Policy and Finance Committee entitled 'The Election of Conseillers 19th August 2020' and to approve the Ordinance entitled 'The Reform (Election of Conseillers (By-Election) (Sark)

(No. 2) Ordinance, 2020'. I would ask Conseiller La Trobe-Bateman to introduce the Report, please.

#### Conseiller La Trobe-Bateman: Thank you, sir.

I will briefly explain why we recommended what we did last week and why we have to re-sit today and hopefully make the change. When the by-election dates were being discussed, the Speaker reminded P&F that there was a precedent set by Chief Pleas where they did not approve the Ordinance and a by-election did not take place. However, this was in 2005 before the Reform Law came into force.

It was also noted that the general election usually generates a higher voter participation and a higher number of candidates. There were no candidates for the last by-election, and there are currently no indications that candidates will be forthcoming for the next by-election.

For this by-election, two of the current vacancies would end at the general election in December and two would be eligible for another two years, until December 2022. Advice was given immediately prior to the Midsummer Meeting. However, this advice was partly verbal and non-specific and the report was presented as tabled. After the Midsummer Meeting further advice was given. This was specific and indicated that the actions of Chief Pleas, although taken for practical reasons, contravened the Reform (Sark) Law, 2008, section 23A(1) and (2) of By-elections.

Under the Human Rights (Bailiwick of Guernsey) Law, 2000, the failure to hold a by-election as required by law could constitute a breach of the right to free elections. Policy and Finance wish to ask Chief Pleas to revoke the decisions taken at Midsummer and approve a by-election on 18th August 2020.

The Committee would also like to apologise for bringing a Proposition to Chief Pleas which could potentially be unlawful, hence the reason for a swift calling of this Extraordinary Chief Pleas to rectify this mistake.

Policy and Finance will be seeking advice on how to amend the Reform Law to give the ability to defer a by-election, should the occasion reoccur in similar circumstances so close to a general election.

**The Speaker:** Do I have any questions or debate from the floor, please? Conseiller Ventress.

**Conseiller Ventress:** I have to vote against Proposition 1, for two reasons: financial and common sense.

This by-election, which should have been called for earlier, became — as did Guernsey's general election — impossible to hold, due to the dreaded lurgy. Hopefully, this has now passed us by. We made the right decision at the last Meeting to defer filling these vacancies until November's general election. This was, in my and others' opinion, the right thing to do. Why? Because should there be anybody wishing to stand and be elected, they would only have from 21st August until the sitting of Chief Pleas on 30th September to digest and assimilate the agenda, propositions and background of the items being brought forward, plus any research they may need to conduct. This is usually a heavy sitting with complex items.

The other reason, and some would say the more important, is the cost of holding the by-election, especially with a severe fiscal impact on the budget by the said lurgy. We have a duty to the taxpayer to save money where possible, and this is one of them. We are told from Guernsey that we *must* have a by-election – *that is the law*. Laws are made by lawyers and common sense has no place in it. Surely Chief Pleas ought to be able to apply common sense to its decisions.

I did have some things written down but listening first to Conseiller La Trobe-Bateman and then to Conseiller Ventress, I would like to back up what Conseiller Ventress has said and I do totally agree with him.

On the other hand, the explanation of these events leading up to this Extraordinary Chief Pleas from Conseiller La Trobe-Bateman has cleared up a few of my questions, so thank you very much.

**The Speaker:** Anybody else? Conseiller Plummer.

**Conseiller Plummer:** What if this Proposition falls? Where will we be standing then legally? Can anybody help me, please?

The Speaker: Conseiller La Trobe-Bateman.

Conseiller La Trobe-Bateman: Thank you. I will try and answer.

Conseiller Ventress: I think just because of a cost implication should not be the deciding factor whether we have good governance and a proper democracy. I think a by-election is a big tick for good democracy. So I think that we have to do it and it is not impossible to hold a by-election because of COVID, as we are proving that with the dates. I know it is going to be an inconvenience for everybody. But again, if it is good governance, I think we have to do it. Okay?

And sorry, can you remind me of your question, Conseiller Plummer?

Conseiller Plummer: I was just asking, if this Proposition fails, where would we be legally?

**Conseiller La Trobe-Bateman:** I think we would probably be in a place we do not want to be! And I do not really want to find out, so I would urge you to vote for it, please.

Thank you.

**The Speaker:** One of the mechanisms available to the public, if Chief Pleas were not to hold a by-election, which was a decision at the last Meeting, is that an elector who decided that he wished to stand and was being prevented from standing could launch a judicial review into the decision of Chief Pleas, and that judicial review would probably say that Chief Pleas had acted unlawfully and therefore, we would be told by a court to hold a by-election.

So I think the issue would be if an elector brought a judicial review because Chief Pleas had contravened the Reform Law.

Anybody else? No? In that case we will go to the vote on Proposition 1, that Chief Pleas rescind Proposition 2 on Agenda Item 14 brought before the Midsummer Chief Pleas, 8th July 2020. Those in favour? Those against? I declare that **carried**.

Proposition 2: that Chief Pleas approve the Ordinance entitled The Reform (Election of Conseillers) (By-Election) (Sark) (No. 2) Ordinance, 2020. Those in favour? Those against? **Carried**.

This ordinance is allocated the number V/2020.

#### **Procedural**

**The Speaker:** Before I close the meeting with the Grace, I just want to quickly go through the timetable, which is a revised timetable which you have had with your papers. The one change on

it is that there will be a notice in the Sark Gazette Officielle and in the St Peter's Church notice box of the forthcoming election. The notice gives the dates and times when final nominations are to be received.

Nomination forms will be available for collection from the Speaker's Office prior to nominations opening and nominations open on Monday afternoon at one o'clock. Therefore there is not a lot of time for people to come in in advance.

However, there is a two-week period of time for people to consider standing for election and coming and collecting a nomination form and having it completed. The nominations close on Friday, 31st July and my Office will be open between 10 a.m. and 12 noon, for anybody coming in at the last minute — and most people come in at the last minute when it comes to elections — and at 12 noon the nominations will close.

The by-election is on Wednesday, 19th August, but of course if by Friday, 31st July there have been no nominations, then there will not be an election. If less than four people put their names forward, there will once again not be a by-election because there are four vacancies. So it needs five people to stand in order for there to be a contested election.

So those are the factors that the public need to consider when coming to a decision as to whether or not they are going to stand for election in this by-election.
