Eulogies –

**Mr Dick Adams, former Deputy of the People;
and Sir David Barclay, former Tenant of Brecqhou**

The Speaker: We are going to start off with two eulogies. One for Mr Dick Adams and one for Sir David Barclay.

- 10 Dick Adams: Dick was born in 1941, during the German Occupation, and lived most of his life on Sark. He was Vingtenier and Constable between the years 1974 and 1976. Those of you who were in church would have heard of his imposing presence on occasions when he was Constable. He entered Government as a Deputy of the People in a by-election in March 1977 and was re-elected at each subsequent general election thereafter, until his resignation after the
15 Michaelmas Meeting in October 1993.

- During his time in office, he served on the following Committees. Oil Pollution, which he joined in March 1978. This Committee was probably as a result of the *Torrey Canyon*, which had happened a few years before. The Douzaine in January 1979, and he was later to serve as Vice-President. Road Traffic, November 1980; Pilotage, January 1985; Sea Fisheries, January 1988;
20 and Harbours, October 1988. He also served on the Shipping Committee as President and it was during his term that the *Bon Marin* came into service. He resigned from the Committee in 1988. He served Chief Pleas for 11 years.

He was, for many years, the foremost Sark pilot and took pilotage courses for Sark boatsmen and for skippers from other islands, France and the UK. He was still qualifying skippers in local

25 waters last year. Dick died on Maseline jetty, on his way to the PEH – a fitting place, I believe, for
a man of the sea – and at his funeral service last week, the skippers and boating community of
the Bailiwick turned out in force.

Sir David: David Barclay, with his brother Frederick, jointly bought Brecqhou in 1993, and
with the authority of the DCC were able to build their castle called Fort Brecqhou. When the
30 brothers bought Brecqhou in 1993, David Barclay became the declared Tenant of Brecqhou for
Chief Pleas purposes and held the seat in Chief Pleas that went with the tenement.

In the year 2000, the brothers were knighted for their charitable works. To the best of my
knowledge, Sir David never attended a Chief Pleas in person, and on those occasions when he
wished to have a voice he sent in a medical certificate and appointed a representative, as
35 allowed by law. However, that system ended with the General Election of 2008, when a fully
democratic Chief Pleas assembly was elected at the will of the people of Sark.

Sir David died on Sunday 10th January and the Lieutenant Governor has copied me into a
letter of condolence that he wrote to Mr Alistair Barclay, which I shall now read:

I wish to express my deepest condolences on the recent sad news of the death of your father. I had the pleasure
of meeting Sir David twice. Whilst his relationship with Sark and elsewhere in the Bailiwick of Guernsey was not
without its bumps, what was in no doubt was his deep affection for Brecqhou and, indeed, the whole of the
Channel Islands, together with his heartfelt desire to see them prosper. On this basis alone, he will be sorely
missed. Please pass on my sincere sympathies to the rest of your family.

Could you please stand for a silence for Dick and Sir David.

Members stood in silence.

STATEMENTS

Development Control Committee – Statement by Conseiller Couldridge

50 **The Speaker:** We now have a couple of Statements and the first Statement is from the
Chairman of the Development Control Committee.

Conseiller Couldridge, please.

Conseiller Couldridge: Yes, thank you, Mr Speaker.

55 It is just a very brief Statement. So thank you all for your attention whilst I make a brief
Statement on behalf of the Committee, DCC, outlining the activity over the past year and our
intentions moving forward.

The view of DCC is that our role is to, where at all possible, preserve the natural beauty and
landscape of the Island and preserve our architectural heritage, whilst being mindful of the
needs of the community. In 2020, the Committee processed approximately 55 applications for

60 planning permissions. This included: 13 for wall, window, door, fences, and so on; 17 for sheds,
greenhouses; seven for extensions to existing properties; three for solar panel installations; one
turbine; one new build, which was the Dairy; four for siting of containers, which were eight
containers in total; four for demolitions in part or whole; four for signs; and two for extension of
65 existing permissions. In addition to the above, there were two refused applications and one
appeals tribunal, which was upheld.

Finally, it may be worth noting that the majority of applications will be considered by the
Committee over at least two meetings. The Committee are also mindful of a likely increase in
demands and pressures as a result of the rising population and the advent of land reform. We
therefore hope to develop more robust procedures and policies to cope with this eventuality.
70 Also, the new Special Committee, Development Control Law, will assist with this process.

Finally, the Committee would wish to offer a vote of thanks to our CSO, Antony Dunks, for his
continuing hard work, support and knowledge, which has proven to be invaluable. We also offer
thanks to the Law Office in Guernsey, who readily offer their support and advice whenever
needed.

75 Finally, the Committee would wish to welcome Conseiller Edric Baker on his return to DCC,
where his vast knowledge and experience will be very welcome.

**Medical and Emergency Services Committee –
Statement from Conseiller de Carteret**

The Speaker: A Statement from the Medical Committee, from Conseiller de Carteret, please.

80 **Conseiller de Carteret:** Thank you, sir.

The Medical Committee would like to update everyone on the vaccine programme for Sark.
The AstraZeneca vaccine was delivered to Sark on Tuesday 12th January, and once the official
paperwork was completed to allow our medical staff to administer the vaccine, they began
vaccinating the over-80s and our front-line workers. This happened on Friday 15th and Saturday
85 16th January. We have now successfully vaccinated around 40 patients from the first category
with their first dose, and their second dose will be scheduled in the up-and-coming weeks. Sark,
together with the other Bailiwick islands, will continue vaccinating certain categories during the
next few weeks, as recommended by Guernsey and the UK. The next category of patients will be
the over-75s. We anticipate receiving regular batches of the vaccine from Guernsey, but this is
90 always dependent on a supply from the UK.

The Committee would like to take this opportunity to thank the following. To Dr Brink and all
the Public Health team who have supported Sark during the pandemic from the very beginning
in March 2020 and who have continued to do so with regular updates, and especially for all of
their hard work during the vaccination programme.

95 We would also like to thank our own medical team here on Sark, who have worked tirelessly
to ensure this vaccination programme has been implemented quickly and efficiently for all our
residents. We would also like to pass on our appreciation to the ambulance drivers who have
had an extremely busy time during the past few months transporting COVID passengers around
the Island to their isolation address, and to the Constables who have had to contact and monitor
100 all the COVID passengers who arrive on Sark to ensure that they are following the strict isolation
guidelines and regulations to protect our community. But most of all, we would like to thank
everybody for keeping our community as safe as possible during this pandemic.

195 We were very careful not to put increased charges on the front of the Report, so it did not put too many people off, but I have to say that the Report has been out now and the general public have all read it obviously and seen it, and I have not had one enquiry as to why the permit prices are going up.

200 The water: it all started with the cost of the water test. The cost of the water test had been increased for a significant number of years. When carrying out a cost analysis of the water test, it was found that we were actually undercharging and losing money, and it was not sufficient to cover the cost incurred. So that is why we want to put it up to £32, and the permits likewise. The fee for the catering accommodation permits have not been increased in some time and in order to cover the administration cost, we feel that the increases that we are asking for are not too far out of the park. But they are for 2022, not for 2021.

I would like to thank David Cocksedge for the many hours he has given to the Committee, the numerous meetings and reports; Ms Dewe for the annual land fishing figures; and a big thank you to the late Dick Adams for all his help with the fishing. He was always keen to pass on his incredible knowledge of marks and fishing methods to any youngster who was keen to learn and he took a large part in forming our present Fishing Ordinance. Along with Caroline Bell, they brought about Sark’s pilotage laws. This knowledge of rocks, tides and marks have been passed on to many Channel Islands skippers. The seafaring community will be a poorer place without Dick Adams.

Conseiller Sandra Williams: Thank you very much.

265 I have not really got a lot to add to last year, apart from I would like to thank, on behalf of the Island I think, the majority of the self-catering places and the hotels and just everybody that actually got together and had to undergo huge, very rigorous study of how they do things and the changes that they would have to make in order to open their businesses last year. I think it was Sark pulling itself together and making Sark the community it is. Everybody was lending everybody hand sanitiser and everyone was lending everybody until it could all come on the boat, because all of a sudden it appeared that from having no visitors at all that we were actually going to be opening up to Guernsey very soon. I was very keen that as many places on the Island as possible would open up. As it proved, I think a lot of the businesses have had a far better season than they had ever anticipated having.

270 So I would like to thank them all on behalf of the Tourism Committee and the Island of Sark for pulling out all the stops there. The visitor numbers were not great, but they could have been an awful lot worse, and I think we need a vote of thanks to the people of Guernsey that seem to have found us again and decided that we are not such a bad place to visit after all. *(Laughter)*

280 I just want to walk through a few of the projects that we have done during 2020 that, in our opinion, have really made a big difference. The Liberation Route, which we are now doing with Visit Guernsey, is quite high profile. It will be on the Guernsey Way, it will be on all of the Liberation routes and we are having little icons done for our signposts so that when people come here they will see the little blue markers which tell them that it is part of the book that they can buy.

285 I think the most important thing to mention this year is the War Years exhibition from last year. It has given *many* people in Guernsey very many hours of joy on a wet rainy day in Sark when they have been here for three or four days and I think people have just been

overwhelmed by the amount of information and there is more information to come in 2021. We have still got another two panels to finish.

290 The QR trail also *in situ* around the Island, imparting historic information about the places that we have. You just click on it with your phone, if you have one, and it brings up the place where you are, the building where it was built, how long it has been there, a little bit of general history, and then just a few things we want to do through 2021, which I noticed have already started. We have had these new fingerboards made, because as much as we invested quite a lot of money in them about eight or nine years ago, they are not quite doing the job.

295 So we looked into having some new posts put up. We have got the signs that have been made on Island by Mr Christopher Beaumont – has engraved them all himself and painted them. They last up to 30 years and so we are moving forward with that. Really there is not much else to say about next year. We are going to do our ‘30 bays in 30 days’, introduce a few more, but we are very much geared up and aiming for just Bailiwick this year.

300 The print of the brochure we do not believe will happen this year, because the majority of the brochures that we printed are still actually sitting in the old Island Hall and have not been used at all. We were thinking of changing pages, but in fact, to send all the brochures back to Guernsey just to have the covers changed and to have information updated inside costs as much as it would cost. So at the moment, we are going to monitor what is going on with the request brochures, direct everybody to the website, and look into maybe managing, if all of a sudden in 305 March or April we look like we are going to be open to France and to England, then we will definitely look into having a small amount of brochures printed.

I have not really got anything more to say.

310 **The Speaker:** Thank you.
Any comments or debate, please raise your hands.

Conseiller Makepeace: Yes, sir.

315 **The Speaker:** Conseiller Makepeace. Anybody else?
Conseiller Makepeace.

Conseiller Makepeace: Thank you, sir.

320 I would just like to ask the Chairman of Tourism if it is possible for us to open the tourist office on a Sunday this year, because we could possibly stagger the hours of the staff to provide some cover, because it has been a comment that I have noticed from people that the office is not open on Sunday. Would we be able to rectify that?

325 **Conseiller Sandra Williams:** It was one thing that I meant to have got the information from when I was at the office this afternoon and I forgot to get then. We opened the office on Sundays from, I think, 3rd or 4th April until the middle of September and the amount of people that went into the office on those mornings did not ... Well, we did not sell anything, hardly any information was handed out, because it was very different this year obviously, with only having Guernsey people. We have monitored it. We did have the office open for three hours, two hours, up to three hours, for the height of the season this summer. It is certainly something that 330 we will look into again for this year going forward.

The Speaker: Conseiller Baker.

335 **Conseiller Baker MBE:** Yes, sir; just like to comment on the new signs.
The late Conseiller Dave Melling and Constable Peter Cole developed the signs that we have at the moment and they were sourced because they were strong, durable, virtually vandal-

proof, because they are not the sort of thing that you can bend very easily without hurting yourself. I see with interest the new signs and I hope they do last.

You say in your report they are hard wood. Do you know what type of wood it is?

340

Conseiller Sandra Williams: Not off the top of my head, but I am sure that Mr Beaumont would know.

The Seigneur: It is accoya.

345

Conseiller Baker MBE: Accoya? Thank you.

The Speaker: And where does that come from?

350

The Seigneur: It is a specialist wood that has been treated. It is a soft wood that has been acetylated so it becomes, effectively, a hard wood.

The Speaker: Right. Thanks.
Anybody else? No.

hopefully 2021, some of the Guernsey contingency might bring the carriages out. We did not see
375 many this year, but the law will still be in place just to keep everything safe and working
properly.

380 **The Speaker:** In that case, we will move to Agenda Item 12, our final Information Report,
from the Agriculture, Environment and Sea Fisheries Committee entitled the ‘New Abattoir
Information Report’ and I would ask Conseiller Plummer to introduce the Report, please.

Conseiller Plummer: Thank you, sir.

385 First of all, I would like to correct a spelling in this Report. It is the heading and it is ‘Abattoir’,
the spelling of abattoir: it is in fact, a-b-a-t-t-o-i-r; not a-b-b. Thank you. And then, may I carry
on? **(The Speaker:** Yes.) Thank you.

390 The Abattoir has started well. Some snagging, minor issues are being taken care of. We are
about to look into the processing of a review into the economics of the Abattoir in the first two
months of use. We have been encouraged by the response from the farmers.

At this point, I would like to thank Mr Philip Long, who has been out, has taken up temporary
management appointment, and he has been working very hard with this, with this new, along
with Mr John Robinson. Philip also went over to Guernsey and he met up with States’
slaughtering people over there, and he was very pleased and learnt a lot. He also managed to
395 make a meeting with Environment and Public Health over there, so he is hoping to further this
along. We will be advertising for a replacement management, as Mr Long has said he could only
do this until the end of March.

400 The water pipe has been laid between the borehole at the bottom of the hill. The
environmental people from Guernsey said that it would be the best solution to have fresh water
going up to the Abattoir this time. We have been putting in plans with the DCC, with the help of
Mr Tony Dunks. The plans have been in and we just have to wait to see if we can build a small
pump room/pump shed right next door or even adjoining, I believe it is, to the one that is
already there and to tidy up the area down there. I just hope that when we come back at the
Easter, we will be able to give some further details on how everything is going.

405 But yes, I am really pleased with the way that it has been turning out. Thank you very much.

445 The Emergency Powers (Coronavirus) (General Provision) (Bailiwick of Guernsey) Regulations,
