# The Transfer of Funds (Sark) (Amendment) Ordinance, 2024 – Policy and Finance Committee Report considered – Proposition carried

To consider a Report with Ordinance and Proposition from the Policy and Finance Committee entitled 'The Transfer of Funds (Sark) (Amendment) Ordinance, 2024'.

#### Proposition:

That Chief Pleas approves 'The Transfer of Funds (Sark) (Amendment) Ordinance, 2024'

The Speaker: And without further ado, we will move immediately to Agenda Item 1, which is to consider a Report with Proposition from the Policy and Finance Committee entitled 'The Transfer of Funds (Sark) (Amendment) Ordinance, 2024' and to approve the Ordinance entitled the Transfer of Funds (Sark) (Amendment) Ordinance, 2024. And I would ask Conseiller Guille to introduce the Report, please.

Conseiller Guille: Thank you, sir.

The Ordinance amends the Transfer of Funds (Sark) Ordinance, 2017, for the purposes of ensuring that the way in which the Ordinance gives effect to the EU regulation on information accompanying transfer of funds — Council Regulation (EU) 2015/847 — in Sark continues fully to reflect the current international standards. It addresses comments made by the Moneyval evaluation team in respect of the Ordinance, on review of the technical submission made to Moneyval prior to the evaluation.

Similar Transfer of Funds Ordinances are in place in Guernsey and Alderney, and similar amending Ordinances have been prepared for those Islands for enactment this week. The amendments make a very minor change to the financial threshold for requiring certain information to accompany the transfer of funds. The EU Regulation imposes the requirements in respect of transfers exceeding €1,000, but the FATF criterion 16.4 specifies €1,000 *or* above. The Ordinance addresses this very minor discrepancy.

The Ordinance also imposes an additional reporting requirement in any country affected by suspicious wire transfers in certain circumstances, FATF criterion 16.7. His Majesty's Comptroller has certified that under the provisions of section 41 of the Reform (Sark) Law, 2008, it is his opinion immediate enactment of the Ordinance ... Sorry, that is irrelevant, the last ... Immediate enactment of the Ordinance by the Policy and Finance Committee is necessary and expedient in the public interest. We have not actually gone down the section 41 route. We have gone straight to a full and proper Meeting of Chief Pleas, which we felt was more appropriate in the timescale.

So I would encourage Conseillers to support this sensible piece of housekeeping in order for Sark and the wider Bailiwick's good reputation financially throughout the world.

Thank you.

The Speaker: Thank you, Conseiller Guille.

Are there any questions or debate from the floor before we move to the Proposition which you have before you? Any questions or debate for Conseiller Guille on this Agenda Item? It is all – Yes, Conseiller Delaney; thank you.

**Conseiller Delaney:** Thank you, Mr Speaker.

I will make some comments, just so we are not a nodding dog parliament; a nodding head parliament. I just wonder what would be the implications ...? I am just looking for a general view now: were we to have problems with this, what would be the implications were we not to vote it through? I wonder if the Chair of P&F could just give his views on that. I am not saying we are not going to, but I just wonder what ... We are exercising a right of this parliament to either vote it through or not, I would just be interested in any thoughts on that.

**The Speaker:** Thank you, Conseiller Delaney. Conseiller Guille, would you like to respond?

Conseiller Guille: Yes. If we were to not vote it through, we would be ... These little loopholes and discrepancies have been identified as part of, you might say, the hyper-focus of the Moneyval evaluation process. They have identified weaknesses in the regulations across the Islands of the Bailiwick and I think to keep Sark and the Bailiwick as a whole, and keep our reputation well maintained financially, it is good practice for Sark and the rest of the Bailiwick, if we tighten up.

It might seem very minor, and we have had to call a Meeting of Chief Pleas for literally amending a few lines of Law, but these things can have very large repercussions internationally and reputation-wise. A lot of work has been done in the last decade or more to improve the Islands' – and I mean all of the Islands, the Bailiwick of Guernsey and Jersey – to improve their reputation internationally and I think it is a sensible path to continue upon.

The Speaker: Thank you, Conseiller Guille.

Are there any further questions to P&F regarding the legislation that you see before you? Conseiller Delaney again; thank you.

**Conseiller Delaney:** Yes, thank you, Mr Speaker; and I am grateful to the Chair of P&F for his answers on that.

I will vote it through. I will be voting it through on the basis of the credibility that I give the Chair of P&F that he has a far greater understanding of the matter than I do. It would be no secret, Mr Speaker, I come from Irish Catholic stock and up to when I was about seven or eight years old I would attend mass and the entire service would be in Latin. Did not have a clue what was being said up on the altar, we nodded away; and talk about a blind faith situation.

I think this is one of the easier things that have been put before us to get to understand, but I do go back to a point that I made several Chief Pleas ago that when we were being asked to vote more complex matters through, for the benefit of the Bailiwick, I feel it would be very helpful if prior to Chief Pleas a member of the law office in Guernsey came over, gave us a good briefing.

I think I make my point being that I do not like blind faith. I will run with it this evening, but I would very much appreciate if we got good briefings from the Law Officers. I am sure they would have constructive comments from us we would be very grateful to hear from, so we knew when we come to Chief Pleas and we were voting these things through, we were making considered judgements based on the evidence that the law office would lay before us.

So thank you for that.

The Speaker: Thank you, Conseiller Delaney.

Would you like to respond to that, Conseiller Guille?

**Conseiller Guille:** Yes. I absolutely support that. Definitely, where we have got some more, not substantive – where we have got bigger items that run into many pages to consider, absolutely a briefing for all Members of Chief Pleas, by the Law Officers or maybe other appropriate officers or representatives from Guernsey's financial industry would absolutely be appropriate.

Again, the two pieces in this are ... the first one is just a correction of it used to say a sum over €1,000 and the correction is to now say a sum of €1,000 or over. So you have captured the €1,000, there. And the other change – if I can expand on it any more – made by the Ordinance, which is in respect of the duty to make a suspicious activity report about transfers.

Currently such reports are filed with the Financial Intelligence Unit in Guernsey. The change provides that where a money transfer service controls both the sending and receiving side of a transfer, such a Report should also be filed in the other jurisdiction as well as locally. Again, this is to clamp down on international money-laundering and the funding of terrorism and such things like that. And where they are attaching to reports about other transfers, it is transfers that may ... some of them may drop in below a threshold for reporting, but they could still be suspicious.

So it is putting the onus on people involved in such businesses within the Bailiwick to keep a keener eye so the Bailiwick does not get inadvertently involved in international money-laundering and such things.

But yes, absolutely, where appropriate, we will request briefings from relevant officers or persons for Chief Pleas Members, because I very much appreciate these are complex subjects, which I do not think is normal business for any of us here today.

**The Speaker:** Thank you for that context and clarity, Conseiller Guille.

It is important to add as well that there is an excellent financial crime investigation unit in Guernsey, which operates solely, I think, on tip offs, you may call it, and information from the public, if they are suspicious of any activities. And that is always something that if someone thought that something was untoward, could use the services of.

**The Speaker:** Thank you, Conseiller Makepeace.

I am not allowed to pass comment on such issues, but I would concur with what Conseiller Guille has said: we would all have preferred to have more notice about this. The thought of doing legislation on the hoof is a big concern, certainly to Chief Pleas as a body. And this, unfortunately, if it was more complex than it is, would be a major issue to have to consider within a two-day period.

So I concur entirely with what has been said, while I am not expressing any particular political view, but in terms of the way in which Chief Pleas is given time to consider, I think it is very important that that is respected and Conseiller Guille has made that quite clear. That is the message from this Assembly, as I see it. So thank you for making those points.

At that point, I shall get back in my seat. Are there any other questions before we go to the vote on the Proposition?

Conseiller Plummer; thank you.

#### **Conseiller Plummer:** Thank you.

I would just like to say that I have read it through, in my own simple mind, and it would be very dangerous if we did not pass this through. We would be a standing target for any of the terrorists or people who are dishonest to use us. Just to make that comment.

The Speaker: Yes. Thank you, Conseiller Plummer. Thank you very much. Are there any other comments or questions for P&F before we go to the vote on the Proposition? No.

Well, in which case, thank you. We will go to the Proposition, which reads as follows: that Chief Pleas approves the Transfer of Funds (Sark) (Amendment) Ordinance, 2024. Those in favour? Thank you. Those against? **Carried**.

Conseiller Bateson: Yes. It is my understanding that at the last Chief Pleas, when the announcement of the appointment of the new Assistant Constable was made, we should have taken a vote on the matter, and we did not do. So tonight I think it is intended that we are going to have a vote. Is that correct?

**The Speaker:** Yes, Conseiller Bateson. (Interjection by Conseiller Bateson)

Can I just give some clarity to that. We got to that Agenda Item late at the Easter Meeting, after a fairly long and lengthy Meeting and I was ... Remiss of me, as Speaker, I should have asked for it to go to the vote. So given the opportunity tonight, I asked Conseiller Bateson effectively to represent it, and therefore it is, if you could please, Conseiller Bateson, give the name again, and I will go to the vote on it, please.

**Conseiller Bateson** Yes. Just to remind you, it would be the newly appointed Assistant Constable is Mr Jordan Burton.

**The Speaker:** Very good. (**Conseiller Bateson:** Yes.) Thank you.

So therefore, those in favour of Jordan Burton becoming the new Assistant Constable, please could you raise your hands? Thank you. Those against? **Approved**. Thank you.

It is a piece of housekeeping, so I am very grateful to the Douzaine for coming back so promptly with that. Therefore I confirm that Jordan Burton is appointed the new Assistant Constable.

# Regulations laid before Chief Pleas – The Charities and Non Profit Organisations (Sark) Exemption Regulations, 2024

The Speaker: Before we close the Meeting, there is just one further Item which I would just like to say a few words on. It is a laid before and it is the Charities and Non Profit Organisations (Sark) Exemption Regulations, 2024.

Again, I would not ordinarily pass comment about this, but this arrived at very short notice and I was intending to bring this as a laid before Item at the Midsummer Meeting. But once we knew that this Meeting today was happening, I thought I would take the opportunity just to say that these Regulations have been made by the P&F Committee under Charities and Non Profit Organisations (Registration) (Sark) (Amendment) Ordinance, 2024, and will stand unless annulled by Chief Pleas. This is advice that we have been given via the Law Officers in Guernsey. It is a question of whether Sark Chief Pleas approves it or annuls it.

If I could take a simple vote on whether anyone ... Conseiller Guille, would you like to say something? Thank you. (Interjection by Conseiller Guille) Yes.

**Conseiller Guille:** Thank you, sir.

So at the Easter Chief Pleas Meeting, the Charities and Non Profit Organisations (Registration) (Sark) (Amendment) Ordinance was approved. This was necessary to show we have adequate controls over the activities of charities and specifically those that are deemed to be international. An organisation is international if it is raising significant sums from overseas or sending money overseas. 'Overseas' in this context means outside the Bailiwick.

For nearly all our charities and NPOs, this has no bearing. However, one in particular, being the Sark branch of the Royal British Legion, remits funds from the Poppy Day Appeal to its UK parent charity. So as not to burden this well-established and well-known local charity, or any of the other currently registered charities which might be doing something similar, P&F passed subsequent Regulations to exempt such existing organisations from being treated as international under the Law. I would therefore recommend Chief Pleas to allow the Regulations to stand.

The Speaker: Thank you, Conseiller Guille.

I would just point out this is not an Agenda Item. It is for your information. So I share that with you based on those facts and I am sorry there is not more clarity behind it than that. Again, it is not a complicated piece of legislation, but it is nonetheless a laid before piece of legislation.

So I just wanted to add that: there is no vote on that, it is for information purposes only. I am very grateful for Conseiller Guille for giving us some background on that.
