- **Office matters**

- **SOO recruitment** – Aidan Mallon had accepted the job. His start date was still to be finalised.
- **Portfolio split** – The Committee discussed the split of committees and priority projects between the 2 SOOs and the 2 CSOs. RR would have oversight of P&F, Medical & Emergency Services and Tourism. Aidan would have oversight of Agriculture, Environment & Sea Fisheries, Douzaine, Education and Harbours, Shipping & Pilotage. They would also each have their own priority projects. There would be a regular review of the portfolio split.

- **Vin d'Honneur**

There would be a Vin d'Honneur for WS on Friday 20<sup>th</sup> February at 5pm in the Island Hall.

- **Future Sark**

The Committee discussed the next steps for the Future Sark exercise.

- **Amendment to Immigration Rules**
