The Douzaine has sought a replacement and will present the name of the chosen person at the meeting.

CHANGE OF GOVERNMENT DOMAIN NAMES

At Easter 2018 Chief Pleas it was agreed to upgrade the existing software to Microsoft Office 365. This was stage one of the review of Government IT.

Stage two is intended to develop and improve the Government websites and eventually enable on-line payments and other services. With this in mind, the 2020 budget contains provision for this work.

Websites.

The Committee office is currently working with our IT consultants and web designers to redesign and update the Government, Medical and Court websites.

In order to improve security and align all Island official websites, it is necessary to change the current domain name from sark.gg to co.uk.

Email addresses: These will also change for example from <u>zannette.bougourd@gov.sark.gg</u> to <u>zannette.bougourd@sarkgov.co.uk</u>

These works are still in the development stage, however significant progress has been made and it is envisaged that the new websites and email addresses will be live in the near future.
