**La Rade** – For an alternative design for the pool room (7.0m x 3.4m x 2.5m high) – **APPROVED**  
**Le Couture** – For a new bungalow (16.0m x 9.0m x 5.4m high) – **REFUSED**

**Treasure Chest** – For an A-frame blackboard sign in front of shop in the Avenue – **CONDITIONALLY APPROVED**  
**Old Hall** – For a roadside sign outside of The Old Hall – **APPROVED**  
**Pourquoi Pas** – To demolish and rebuild the dwelling destroyed by Storm Ciaran – **APPROVED**  
**Beau Sejour** – For a previously approved 'pergola' at the premises – **APPROVED**
