That Chief Pleas requests Guernsey's Policy & Resources Committee to maintain efforts to ensure that Sark's interests (and, subject to the necessary authorisations from Guernsey and Alderney, the Bailiwick's interests) continue to be represented to the UK Government's Department of Health and Social Care during negotiations on the Reciprocal Health Arrangement and any associated arrangements/ agreements.

Proposition 3 – CARRIED.

That chief Pleas authorises Guernsey's Policy & Resources Committee, in consultation with the Committee for Health & Social Care, if the Committee is of the view that the provisions of the final forms of the Reciprocal Health Arrangement with the UK Government's Department of Health and Social Care and any associated arrangements/agreements give satisfactory effect to the principles (set out in Section 9 of the Policy Letter), to agree and enter into that Arrangement and any associated arrangements/agreements, on behalf of Sark, and subject to the necessary authorisations, also on behalf of Guernsey and Alderney.

Proposition 4 – **CARRIED.**

That Chief Pleas directs the Policy & Finance Committee, in consultation with the Medical & Emergency Services Committee, to agree the necessary arrangements with Guernsey's Policy & Resources Committee to implement, monitor and manage the final agreed Reciprocal Health Arrangement and any associated arrangements/agreements.
