**The Speaker:** Moving on to the next items on the Agenda, we have a number of statements this evening, which we have received from Committee Chairmen or Chairpersons, and we also have one personal statement. We will go through these one by one.

## Compulsory purchase of SEL assets – Statement by Conseiller Guille

**The Speaker:** The first statement, I would like to invite Conseiller Guille to give us an update on Sark Electricity.

Conseiller Guille, thank you.

Conseiller Guille: Thank you, sir.

An update on electricity. Firstly, compulsory purchase of SEL assets. On 25th June 2025, Chief Pleas decided to bring the Compulsory Purchase (Electricity) (Sark) Law, 2021 into force. This started the legal process to bring the assets of Sark Electricity Ltd into the ownership of Chief Pleas.

The objective is to ensure Sark has a safe, reliable and affordable electricity supply for generations to come by bringing it into community ownership.

The next step under the statutory process is for an independent valuer to be appointed. A great deal of work has been undertaken by Chief Pleas and its advisers, engaging with nine different recommended valuation firms in order to reach the most suitable and robust proposal. An initial proposal was put to the Managing Director of SEL some weeks ago, though little feedback was received.

Today, on 1st October 2025, the Policy and Finance Committee delivered a final proposal to the Managing Director of SEL to attempt to reach a mutual agreement on the appointment of the valuer. Under the law the appointment of the valuer is made by order of the Court of the Seneschal on the application of either party. The Committee will shortly be applying to the court for an order appointing Begbies Traynor, and it hopes to be able to tell the court that both parties support the appointment, but such mutual agreement is not required for the application to be made or for the court to make an order. A decision has been requested from SEL within two weeks.

The proposed valuer is accountancy firm Begbies Traynor, supported by Hilco Global for the specific machinery and plant valuation aspects of the exercise. The Committee and their advisers believe that Begbies Traynor has the necessary scale and possesses the relevant expertise and experience for this task.

Once compulsory purchase is completed the plan remains the same: all the current SEL staff in Sark would be retained under the new operating company. They would immediately begin the safety and reliability upgrade programme under the supervision of GEL managers and highly qualified technicians. They would also be assisted by outside contractors with a deep and long-earned understanding of Sark's power systems.

September bills. In late August, with less than a week's notice until the next billing cycle, SEL announced two new 'levies' to be applied to the forthcoming September bills. The Sark Electricity Price Control Commissioner has reviewed these proposed charges and determined that they are not fair or reasonable. A Price Control Order has now taken effect from midnight on 30th September 2025. The Price Control Order will cover any bill from October onwards, but will unfortunately not cover the September bills, which should be received in the first two weeks of October.

For September, customers are advised to contact SEL directly with any concerns. Vulnerable residents are encouraged to inform the Island Safeguarding Officer or the Sark Medical & Emergency Services Committee of their situation. Residents are reminded that for the fitment or alteration of any equipment on your property, SEL staff must be given permission by the resident, or the landlord, in order to enter.

Correspondence from SEL. Chief Pleas, along with SEL customers, local media, the Ministry of Justice, the Lieutenant-Governor, and others, have received numerous communications from the Managing Director of SEL in recent weeks. Several opinions have been stated as fact and the Policy and Finance and Future Energy Committees would like to clarify the actual position:

Discussions between Island Power and Sark, not involving SEL, have been held several times since 2019, the most recent being in April 2025. None of the proposals presented were considered to have been financially credible, technically appropriate, suitable from a community perspective, or compliant with the tender process.

The Managing Director of SEL has claimed many times that he has 'sold' SEL to Island Power, yet there is no evidence that such a sale has been made, and Mr Witney-Price still presents himself as the owner of SEL.

On other occasions it has been claimed that Chief Pleas has 'blocked' the sale of SEL. This is not true. Chief Pleas has not blocked the sale of SEL to Island Power or to anyone else; it does not have the power to do so. There is no 'Chief Pleas block'.

Island Power have never claimed to be interested in buying the company. They have consistently proposed a single model where Island Power enters into a partnership with SEL.

Island Power have not provided evidence to show that they have the access to the funds needed to implement the most urgent safety work, let alone the longer-term upgrades. Instead, they have consistently suggested that they would access the proposed £1.5 million loan facility that Chief Pleas has negotiated with the States of Guernsey.

The Managing Director of SEL has also recently made false statements regarding the costs to Sark of legal advice and representation provided by the Law Officers of the Crown. Currently, Sark pays a long-standing Service Level Agreement with St James Chambers to the value of £82,952 for the year 2025. This is reviewed regularly and has risen by RPI in recent years. There are no plans to increase this by £100,000, as stated by the Managing Director of SEL. There are no plans to increase tax by £200 per person on Sark in order to cover legal expenses. The Law Officers of the Crown will be representing Sark in court hearings regarding the compulsory purchase process as part of this Service Level Agreement.

Taxes in Sark will need to be increased for the next year to cover urgent expenditure on other critical infrastructure projects, but none of this will be associated with electricity matters. The compulsory purchase of SEL and the desperately needed immediate safety and reliability upgrades will be covered by the loan facility and subsequently paid back at a fair rate through the unit price of electricity.

Lastly, the most recent correspondence from the Managing Director of SEL to residents has claimed that the compulsory purchase legislation is not human rights compliant. The Committee is advised by the Law Officers' Chambers that this is not the case. All Bailiwick legislation is subject to the Human Rights (Bailiwick of Guernsey) Law, 2000, and is drafted to be compliant with the Bailiwick's international obligations, including under the European Convention on Human Rights; and all primary legislation, such as the law, is scrutinised for that purpose as part of the Royal Assent process. It should also be noted that SEL were consulted during the drafting of the legislation.

Conclusion. Chief Pleas is committed to bringing the assets of Sark Electricity Ltd into community ownership ensuring a safe, reliable and affordable electricity supply for our community. The compulsory purchase process is now underway to deliver this.

On Thursday, 2nd October, the Electricity Price Control Commissioner, Shane Lynch, will hold a public meeting in the Island Hall at 6 p.m. Shane Lynch will also have drop-in clinics on Friday, 3rd October, in the Island Hall boardroom from 2 p.m. to 5 p.m.

It is expected that the Managing Director of SEL may continue to issue statements both publicly and directly to customers. In light of this, the Committee urges calm and unity within the community during this important period. ## Douzaine workstream – Statement by Conseiller Locke

**The Speaker:** The next statement that we have this evening is from the Chairman of the Douzaine, Conseiller Locke.

Conseiller Locke, thank you.

**Conseiller Locke:** Thank you, sir.

I would like to update Chief Pleas on a number of Douzaine workstreams which have not yet reached formal Report or Proposition stage. This is despite a lot of hard work by Douzaine members since we came into office this year, and the team in the Committee office, who also have new responsibilities, for which we are extremely grateful.

In brief, first, Midsummer Chief Pleas directed the Douzaine to draft and publish a guidance note on policies and procedures surrounding rental and leasing of properties vested in Chief Pleas. This note is now in a final draft with both Douzaine and Policy and Finance. Subject to their discussion and final input from the Law Officers, this will be presented to the Christmas Chief Pleas as a Report with Propositions.

As we prepare the Douzaine budget for 2026 and beyond, it is clear there are some significant projects which will need significant funding. The most significant being the work programme over three years to stabilise the Coupée. Following the emergency work in 2025, Geomarine have carried out inspections and submitted estimates. Some works have already been done, particularly on drainage and water runoff to reduce erosion. More will be done this year on the roadway and to improve drainage from the causeway itself via rope access work off the sides of the causeway. This will help protect the underlying cliffs from further erosion this winter.

We are working with Geomarine for the plans for 2026 and 2027 to do as much as we can with local resource; for example, poured concrete as opposed to sprayed, local carpentry for shuttering, local workforce transport and rope access, which should both reduce overall cost and contribute more to our economy. This update will be done within the current budget cycle.

Rubbish disposal is also dependent on cliff stabilisation work at the Harbour Quarry to bring the whole of the quarry back into full operation. To move operations completely to Les Laches would require a new access road as well as new infrastructure buildings. Waste that would need to be sorted for shipment off Island would have to go first to Les Laches and then back down to the harbour, which just does not make sense.

The business case for future rubbish waste and recycling has been informed by discussions with and visits to both Alderney and Guernsey, and there is a balance between the costs for shipping and processing and new equipment needed here for any change to the system. More work is needed to finalise this before a decision can be taken for 2026.

Working on this business case has highlighted that commercial rubbish charges do not cover the costs of dealing with the commercial rubbish. We are working on a new charging scheme which we hope will both cover costs and reflect the general amount of rubbish we have to deal with from commercial sources.

This is not the only area where costs to the Island are not covered by charges made. It is our view that charges made should at least cover the costs incurred. If this does not happen the shortfall needs subsidising by general taxation, which is not fair, or the work does not get done, which is not satisfactory. Surely those who generate the rubbish should pay what it costs to deal with it.

Another area is income from road users. In the UK their tax and duty system raises two and a half times more revenue from road users than is spent on the roads. Here, it is the other way around. What is raised from road users is just over half of what it costs to maintain our roads. That is not sustainable. As with rubbish, any shortfall has to be covered by everybody else's personal capital and property taxes, the impôt and others.

Many of these charges and other licences have simply not kept pace with inflation since they were last changed. Regrettably, this now has to change, and we are working on licences and fees which will reflect inflation since their last change, and/or increases to cover the costs of the relevant services needed to support those areas as much as is possible. We are not happy with that, but equally we do not want to ask for budgets which will mean all residents taxes have to go up unfairly to cover those shortfalls.

There are a lot of other demands on the Douzaine and Public Works' budgets. The sewage system cannot be done in this year's budget. There is necessary maintenance on public property used by Chief Pleas and leased to our key workers. Toilets, used by visitors and us. Much of this has been put off due to stretched budgets in the past but we have come to a tipping point. This cannot be put off any longer.

The last item is an example of this. Our old Island Hall is 97 years old. The main part where the badminton court and snooker room used to be is used by the ambulance station, tourism, medical, fire service, the Douzaine and Public Works. Its foundations have crumbled and the steel joists underneath it have rusted so they are no longer load-bearing. If this is not addressed soon we risk ending up with a pile of rubble, timber and 26 t of asbestos for disposal. The asbestos alone would cost over £22,000 to dispose of at Guernsey, let alone the specialist handling, double bagging and shipping required.

I, for one, would like it still to be upright and still in service for our Island when it turns 100 in 2028. If we let it fall down or demolish it, where do we find homes for all the Island support services that live there now? It is going to be cheaper to keep this going.

Finally, all of these items will be brought back to Chief Pleas as part of the budget process and with further Reports with Propositions from the Douzaine. But the Douzaine wanted to let the House and residents know that, first, a lot has been done to plan the most economical way to address these longstanding issues, and that secondly, sadly, significant rises in charges to cover costs will be needed.

The upside is that we now have a much better understanding of what is needed and the most economical way to get there. We look forward to positive updates for Chief Pleas in the future.

## Spending and tax for 2026 – Statement by Conseiller Guille

**The Speaker:** Following on from that, I would like now to call on Conseiller Guille again to make a statement on spending and tax.

Conseiller Guille, thank you.

Conseiller Guille: Thank you, sir.

We are grateful to Conseiller Locke for his statement about the reality of investment that is needed on Sark. This is the culmination of decades of under-investment in many cases. The challenge is large but it is absolutely not insurmountable. Clearly the bigger projects described by Conseiller Locke, such as the Coupée and the Harbour Quarry, cannot be tackled by increases in licence fees alone. General taxation is also going to have to rise for the next year by a sizeable margin. This will be done as fairly as we possibly can under the existing system.

It has become apparent to many Conseillers, officers of Chief Pleas and residents that our taxation system in not entirely fit for purpose anymore and in need of a significant update. A good deal of work has been undertaken by the Special Taxation Committee and the Policy and Finance Committee to investigate ways to adjust this. These potential changes will of course be well-published and consulted upon. At the moment, the Committees are minded towards a retention of the Property Tax and an overhaul of the Capital Tax system. This consultation and these changes however will not be brought before Chief Pleas in time for the 2026 budget.

This means that significant extra revenue will need to be generated for next year from a combination or taxes, licences, commercial charges and other means. While we are concentrating at the moment on next year's budget we will be turning our focus towards the 2027 budget and tax reform in the latter part of this year and the early part of next.

As always, we very much welcome any and all input from the community. Please do not hesitate to contact members of the Policy and Finance Committee, the Special Taxation Committee, or indeed any Conseillers if you have comments or ideas, both positive and negative, about how the Island should be raising more revenue through taxation or otherwise.

While this is a significant challenge that our community faces, it is certainly not as gloomy or desperate as some like to make out. It is well within the reach of our current population to meet these investment needs, and we look forward to a sensible and frank discussion across the Island in the months to come.

We are pleased to announce that Mr Rhys Rowlands has been appointed to the role of a second Senior Operations Officer, replacing the previous Senior Executive Officer role.

Rhys is currently working as a civil servant with the UK Ministry of Defence, having valuable prior experience in a variety of roles, including with the UK overseas and with the Bank of England.

Final arrangements have yet to be confirmed, but we are hoping Rhys will join us in January at the latest, along with his partner Claire.

After Rhys's arrival our current Senior Operations Officer, William Spooner, has decided to return to the UK to pursue his charity interests focused on developing countries. There will be a substantial handover period between Rhys and William early next year.

## Scrutiny and Oversight Function – Statement by Conseiller Tighe

**The Speaker:** Next up, we have a statement from Conseiller Tighe, entitled 'Scrutiny and Oversight Function'. Conseiller Tighe, thank you very much.

**Conseiller Tighe:** Thank you, Mr Speaker. This is a brief statement on the Scrutiny and Oversight Function, as a reference to a report being brought back to Michaelmas was mentioned at the Midsummer meeting.

The Policy and Finance Committee continues to explore the most suitable options for the proposed introduction of a dedicated scrutiny and oversight function within the Sark system of government. We are grateful to members of the public who have provided feedback and insights to date, which have been invaluable in shaping early thinking.

It is recognised that scrutiny and oversight already occur within the House itself, as Conseillers themselves must approve any Propositions, providing an important layer of review. The recent visit by Stephen Twigg and Sarah Dickson highlighted the potential for this function to develop and evolve, and the Commonwealth Parliamentary Association, the CPA, could also provide useful scrutiny benchmarks from jurisdictions of comparable sizes. We also hope to engage further with the tribunal panel members regarding their potential involvement as this work progresses.

Looking ahead, we plan to hold workshop sessions with Conseillers and members of the public to develop initial proposals for a scrutiny and oversight function. These proposals could then evolve over time to become proportionate and fit for purpose for a jurisdiction of Sark's size. Further updates will be provided as the proposals are refined.

Channel Islands Joint Visit to the Nuclear Facilities on the Cotentin Peninsula. From 14th to 17th September, I visited the French nuclear facilities on the Cotentin Peninsula as part of a joint delegation from the Channel Islands. The delegation comprised members of the Jersey Emergencies Council, members of the Guernsey Civil Contingencies Authority, representatives from Alderney and Sark — although the Alderney representatives were unable to join us due to poor weather affecting travel — members of Jersey and Guernsey Radiation Advisory Groups, and Jersey and Guernsey Assistant Emergency Planning Officers.

The purpose of the visit was for political representatives, together with members of the Islands' radiation groups, to familiarise and gain an overview of the inside operations of the nuclear facilities on the Peninsula and gain assurance of the safety culture within the facilities. The visit also allowed the opportunity to meet with La Préfecture de la Manche.

Throughout the visit, we were impressed by the layers of safety in the sites we visited and the liaison between the authorities and the local communities. The visit also allowed for valuable networking between the Channel Islands delegations. It was especially useful to meet and spend time with political and Civil Service colleagues from Guernsey and Jersey, both long-term Members and those newly elected.

I wish to thank the organisers and La Préfecture de la Manche for their time and hospitality, and the Guernsey and Jersey Emergency Planning Officers for organising the trip. Thank you.

## Yellow-legged Asian Hornet Control Report – Statement by Conseiller Plummer

**The Speaker:** Next up, I would like to invite Conseiller Plummer from the Agriculture, Environment and Sea Fisheries Committee to give a statement about Asian Hornets.

Conseiller Plummer, thank you.

Conseiller Plummer: Thank you, sir.

Yellow-Legged Asian Hornet Control to the end of September 2025; this paper was put together by Peter Cunneen.

The overview. This year has been exceptional in both the numbers of queens trapped in the spring and the numbers of nests across Sark. The wind directions from the start of April through to the second week of June, when queen-trapping stopped, were predominantly from the north-east around to the south. The consequence of this was migration on both fronts from both Normandy and Jersey.

Spring queening. Many thanks to the 58 Islanders who, using more than 70 traps, caught 137 queens. This is a record surpassing those of the two previous years; 30 in 2024, 24 in 2023. Once the nest tracking is complete at the end of October, we will submit a report for the year, which will include recommendations on improvements for spring queening in 2026.

Nests. One primary nest, complete with a queen, was found and destroyed but the other two live primary nests that were discovered had already seen the queens migrate across to the secondary nest. Until this year, no primary nests have ever been found on Sark. Tracking has been extremely difficult this summer because of the proximity of nests to one another and the fact that the discovered nests were not destroyed sooner. The trained person responsible for destroying nests in Guernsey has taken on a new role, so his availability was limited until September. As ever, we are extremely grateful to Guernsey for the support and help that they extend to Sark, and to the Sark population for their help also.

Up to 30th September 2025, six secondary nests have been found. Two very large nests, discovered on 29th September in the Le Manoir Orchard and at the bottom of Stocks' Meadow, are scheduled destruction on Wednesday, 8th October. The road running from the Cider Barn towards a church will require closing for a period during the morning when the nest is treated. An unreachable nest in Greve de la Ville, dealt with by Nicky Dewe and Andy Cook, now requires a few more volleys from a shotgun (*Laughter*) as it has reconstructed itself. As I say, the Guernsey team are coming over on 8th October.

Some nests this year have been quite tricky to deal with and have involved the use of the crane and tree surgeons at the back of Clos d'Iris, a telehandler and tree surgeon at Clos à Jaon, and the use of a boat and shotgun in Greve de la Ville. Nests must be recovered after treatment for fear of contaminating the food chain, hence the use of a tree surgeon when it is beyond our capabilities.

Remaining nests. Our bait does not currently attract the hornets, which means that our new tracker cannot be used effectively. Based on our early observations, we believe that there are possibly another 12 nests to locate. As the trees begin to thin, and with the ivy in bloom and the hedges full of insect life, we ask that everybody be aware and keep an eye out for nests. Also, remember that the nests can be in bushes, brambles and walls, so take great care when cutting foliage outside and when using machinery. The hornets give a deep hum that, once heard, is never forgotten. I ask everybody to be vigilant for their safety.

This is going to be my last Chief Pleas, as I have decided to step down as a Conseiller. I felt it was important to announce that here so I can briefly – although not so briefly, you know me – explain the reasons I am resigning, as well as express my regret and apologise to the electorate that I will not be seeing out my full term.

There are two elements to my resignation: the personal and the political. There is a great deal going on in my personal life at the moment where I am subject to significant changes, challenges and developments. I will not go into the detail of that here but it demands my fuller attention and, in this context, I need to feel that there is a purpose and a point in me being a part of this Chamber.

I stood for Chief Pleas as I could see that the Government was on a bad track of overspending on revenue expenditure without sufficient plans for developing revenue, not least for the various capital programmes that we have heard about this evening. I have made proposals over the last couple of years in here and in PDG for various ways to restrain revenue expenditure, but they have not proved particularly popular.

I was alarmed also at the imminent prospect in 2023 of the Island inviting direct managerial oversight of the Civil Service from Guernsey. You have all heard me say this before. In my understanding, that would have been a significant step towards losing our constitutional autonomy that would have perhaps restricted our ability to shape law, to develop some of the revenue streams that, at the moment, the Island could still potentially make happen.

Now, we have had the Island, as I would see it, bounced into the Bailiwick Commission with its potential perils for our status. That was a decision from which most Conseillers were excluded in terms of the detailed discussion, and which was instead presented as a *fait accompli* determined between Guernsey and a very few in the Sark Government. I am afraid that I have lost any remaining sense of trust in the group in power here as a result, but I must recognise that the majority of my colleagues do not feel strongly about what I see as this insult to the Assembly.

I spoke to a Member of the States of Deliberation some time ago who said to me that Sark should be careful, lest it become a glorified parish of Guernsey; yet our own authorities here cannot see that risk. Perhaps quietly some may, in perhaps a conflicted way, even welcome the prospect. As things stand, the Policy and Finance Committee continues to erode, year on year, the Island's reserves, while talking a little in public and more volubly in private — but now we are hearing a bit more in public — about plans to raise government revenue by significantly raising Islanders' taxes, as they claim that there are plenty living here who have broad shoulders. This is in spite of last year's tax consultation revealing that Islanders do not want substantially higher taxes and do support exploring ways to better monetise our being a tax-advantageous jurisdiction through exploring a residency scheme.

One imagines that that sensible instinct might support other measures, such as exploring a shipping registry and a corporate registry that could see ancillary financial service companies on the Island providing jobs for the young and, potentially, tax relief for the less-well-off. I know that these are in discussion in PDG, but this should be the primary focus of Policy & Finance, with expert external support in place now, not higher taxes on residents.

Those who have made these and other reasonable criticisms of the Government have been implicitly accused of disloyalty and explicitly told that we are bullies, are selfish, have a dark ulterior motive and should be ashamed of ourselves. This in itself is disturbing to me as it speaks to a culture that, in its basic assumptions and operating mechanisms, is not particularly

democratic but perhaps more autocratic. None of us join Chief Pleas to be loyal to individuals but to the Island.

I find it incredibly saddening that talented people in this Chamber who have critiqued the top Committee's direction and voiced concerns about financial and constitutional stewardship have been as floridly scapegoated and demonised as they have been. I find myself wondering – bizarrely, for a place whose success and potential is built on being a low-tax jurisdiction – if groupthink and class resentment are potential influences shaping the direction of travel, and that question for me is a cause for concern.

However, over recent months of wrestling with the situation, I have reached the point of realising that, as things currently stand in the Chamber and behind the scenes, I am now — and perhaps I always have been, I am unsure — giving my time in vain. I have happily sacrificed time, income and energy, as everyone in here does, to serve. But I cannot do that without feeling that I am having a positive impact. Disheartened, I have in recent times withdrawn from all but my most essential duties and I cannot summon the hunger to throw myself back into the fray knowing that I will not impact the outcome.

Bismarck said that one should not look at laws or sausages being made. Unfortunately, my experience here has left me somewhat without an appetite. My hope is that, given time, the cautious, pragmatic conservatism and respect for process and the rights of this Assembly that I espouse, and which represents a significant current of opinion on the Island, can be heard and not vilified by over-certain members of the in-group.

So I join the list of resignations, the sixth in the two years since I was elected. I have always tried to be transparent and to give this Chamber and the public the respect that they deserve. That is why I have wanted to outline my decision here, rather than leaving a question mark. No evasions, no excuses. I have also never wanted to wash dirty laundry in public and I have not done so. The quid pro quo of that is that we really should run a sufficiently ship-shape laundrette, I think.

I wish good fortune to all those who remain and I hope with my whole heart that the Island finds its way on to a better financial trajectory with sounder decision-making and without a mirage of sometimes unreflexive left-wing thought clouding the judgement of those in and around the top Committee. In the past, this Island has not just survived, but it has also thrived. It deserves to do so again, and it can do so again.

My resignation will be with you tomorrow, sir.

This Agenda Item proposes a formal amendment to the constitution governing Chief Pleas Committees, enabling the creation of a Sark branch of the Commonwealth Parliamentary Association.

To fully participate as a recognised and credible member of the CPA, jurisdictions are required to establish a local branch. The proposed structure reflects established CPA standards and aligns with widely accepted practices across the Commonwealth, especially in jurisdictions of a similar size to Sark.

The establishment of the branch will allow Sark to engage more fully in Commonwealth parliamentary co-operation and will include a mix of elected Members to ensure broad representation and accountability.

I would like to add, for clarification, that within the introduction it states:

Elections for executive committee members (two general vacancies) will follow at the end of the meeting per the normal practice.

Just to clarify, the Executive Committee will have three members elected by Chief Pleas from its serving Members, including one member elected from the Policy and Finance Committee and two members elected by Chief Pleas, at least one of whom shall not be a member of the Policy and Finance Committee.

I urge everybody to support this Proposition.

The Speaker: Thank you, Conseiller Tighe, for that introduction of this Report. Are there any questions or debate from the floor regarding this report?

Yes, Conseiller Makepeace, thank you.

Conseiller Makepeace: Yes, I would just like to refer to a quote from a report from Conseiller Tighe, made on 2nd July this year to Chief Pleas:

In accordance with CPA practice and model branch constitutions, the presiding officer is expected to serve as Chair of the local CPA branch. This reflects the role of the Speaker as the head of the legislature and provides continuity ... in the branch's leadership. This structure is the established norm in CPA branches.

However, there is a glaring omission in this statement in that it fails to add that the rule about the Speaker is only relevant in jurisdictions where the Speaker is already an elected Member of Parliament, such as, for example, the Isle of Man. My research shows there is not one single member of the CPA's small branches that has a non-elected Member of its Parliament as Chair of

685 its branch.

> It was referred to also in the meeting about Richard McMahon in Guernsey being the unelected Chair of Guernsey CPA. This is incorrect, as Mr McMahon is President of the branch, which is a ceremonial title only. Mr Lyndon Trott, an elected Member, is Chair of the CPA. This goes for Jersey as well. Therefore, the Chairs of the branch executive and therefore the head of the branch is always an elected Member of its Parliament.

What P&F are proposing breaks with this principle; making the Speaker Chair would make Sark the only small branch in the Commonwealth where the Chair of the branch is not an elected Member of its parliament. It also creates a ridiculous situation whereby if a vote is tied among elected Conseiller Members, then the unelected Speaker, as Chair, would have the casting vote. There is, however, a role for the Speaker as branch president, which is the normal route in such cases.

The Chair of the Sark branch of the CPA has to be an elected Conseiller chosen by ballot among elected Members. I urge Members, let us not allow an error of governance to damage our reputation. The proposal has to be withdrawn and amendments made as per suggestion.

We hope that there will be some savings in this, in being clear about what is and is not allowable.

Just to be clear again, the expenses must be reasonable, necessary and incurred in the course of official duty, and all Conseiller officers and all employees must seek value for money and use public transport and the most economic options wherever possible. We have provided a claim form, which is at the back of the paper.

Finally, I would like to thank the Treasurer, Sarah Hudson, for all her very hard work on this, because this is a rather splendid thing that she has produced. I hope that you will all be able to support this.

## 940 **Conseiller Cragoe:** Thank you, Mr Speaker.

Yes, this is a bit of an annual task that under the Education (Sark) Ordinance, 2003 the Committee must present every year for review the level of fees prescribed in this section at its Michaelmas Meeting. For those Conseillers who are new, we currently support off Island education for children in years 9 to 11. We provide a tuition cost up to the cost charged to Chief Pleas by the Government of Guernsey for tuition at Les Beauchamps High School, which this year is £9,378.

Parents may use that contribution at a certain number of other schools as set out in the Report that we brought at Midsummer. We also make a contribution for term-time hosting on Guernsey because it is not possible for the children to commute every day. Again, those are rates which are set by Health and Social Care in Guernsey. It is currently £31.25 a day. That is available to parents on a sliding scale, depending on how long a child has attended Sark School previous to year 9.

This is basically just set by Guernsey and it is what we are providing to parents, so I would urge Conseillers to approve this. As I say, it is just a bit of an annual chore that needs to be done, a bit of housekeeping.

**Conseiller Cragoe:** Thank you, Mr Speaker.

This simply is laid before the House. This is the Annual Report which has been provided by the headteacher, Ms Brady, on our wonderful Sark School. It talks about what has been going on in the school last year and also, as she says, just highlights some of the things that are happening in the future.

I will not read through it because I think you have probably all heard, and I fear that you might have to hear from me again. I will just pick out a few key highlights, one of which is the very successful re-establishment of the Board of Governors, which was aided by our expert adviser, Mr Marcus Cooper from the UK, and has been nobly overseen by Jan Guy as the Chair. The Friends of Sark School are doing very well. The children have been on trips, they have brought in a new curriculum, and there is a parent forum, so it is all tremendously exciting. The school is really very splendid.

She has also provided a little bit about this year that has just begun. This paper was actually put together just slightly before the beginning of the school year and the numbers that are given on the roll on the bottom of page 3 are slightly out. We did have one family decide to go to home education immediately before the beginning of the school year and the numbers have gone down. It is quite a large family and it has gone down to 20, I am afraid. It will be going back up to 21 in the spring when another child joins.

Yes, we have all the same teachers, which is very good, and we have had a very successful In-Service Education and Training (INSET) day with an adviser from England, Vicky Mathews, who has come over to help with curriculum development. Just finally to say, I hear that the implementation of the use of the King's InterHigh provision as a part-time provision, that they are doing three subjects which are taught online in; I think it is years 7 and 8, but possibly only year 8. The children are really enjoying it and feel they are learning a lot. It has been very successful, so that is really positive. This is simply an Information Report, as I said; I did not mean to talk that long. You will all read it and appreciate our wonderful school.

Thank you.

**The Speaker:** Thank you, Conseiller Cragoe.

As Conseiller Cragoe says, it is an Information Report and there are no Propositions to vote on, but does anyone have any observations or questions of the Education Committee regarding the Report? I have got two hands up over here: Conseiller Makepeace followed by Conseiller Locke.

Thank you, Conseiller Makepeace.

**Conseiller Makepeace:** Yes, it is just something I am not really too sure of. At the end of the Report there is a table and it says, 'Reading Assessment', 'Maths Assessment' and the percentages, 'Working at expected'. What does that actually mean? Does that mean that they are working at an average or what? I am not really too sure what that means.

Thank you.

**The Speaker:** Thank you, Conseiller Makepeace.

Would you like to answer that, Conseiller Cragoe? Thank you.

Conseiller Cragoe: Yes, I believe that there are standards for each grade or year level. So what this is saying is that the vast majority of the children are either working at the level you would expect of a child of that age and in that year group and that actually quite a substantial percentage for both reading and maths are exceeding that standard. So, we are doing very well actually and the children are learning as they should be.

That is what this means. It is not a standardised test exactly but it is what you would expect a child of, I do not know, seven to be able to do, or a child of nine or 10 or whatever it is. That would be different obviously if they were 7 or 9 or 10. I hope that clarifies for Conseiller Makepeace.

The Speaker: Thank you, Conseiller Cragoe.

Conseiller Nicolle, I will come to you in a moment but Conseiller Locke was next; thank you.

**Conseiller Locke:** Thank you, sir.

Purely coincidentally I was speaking with a member of The Press earlier today who was particularly interested in when the EPCC information will be available publicly. She mentioned that she would usually audit Chief Pleas, and had read all the papers, and she was very impressed with the figures that were contained within this Education Report.

I just thought I would pass that on, particularly that table that has just been referred to. I have absolutely no bias in this whatsoever as I am unblessed with children. So congratulations to our Education Committee. As far as I know. (Laughter)

The Speaker: I do not think we want to know about your past, Conseiller Locke, but thank you anyway for clearing that up.

Thank you, Conseiller Locke.

Conseiller Nicolle, thank you.

Conseiller Nicolle: Thank you, Mr Speaker.

Just to add to my colleague, Conseiller Cragoe, I would just like to add to Conseiller Makepeace that the Sark School is aligned with the English curriculum. What you are looking at there is national standards, so a good majority of our children are working at the national English level, which is very reassuring. Congratulations to all concerned.

A Member: Hear, hear.

**The Speaker:** Thank you very much indeed, Conseiller Nicolle, for making that point.

So there we have it. Are there any other questions that you would like to ask of the Education Committee regarding the Report that you have got before you? Any other questions?

Yes, Conseiller Makepeace, once again, thank you.

Conseiller Makepeace: Just really a general enquiry about the term-time hosts. Is it still difficult finding term-time hosts or has the situation improved or not?

**The Speaker:** Thank you for that question.

Conseiller Cragoe, are you familiar with that situation?

Conseiller Cragoe: Yes, I believe it is still challenging. We do not currently have any years 9 to 11 students, I do not believe, who are term-time hosted. I did meet a parent of an older child today who was talking about their child staying with a term-time host, a post-16 student, so people are still being able to find them. But, yes, since COVID it has been quite challenging. It is

Next, please, to Education, and we have two vacancies on Education and I would ask Conseiller Cragoe for your nominations to join the Education Committee. Conseiller Cragoe; thank you.

Conseiller Cragoe: Thank you.

I would like to nominate Conseiller Keyte and Conseiller Moloney, please.

**The Speaker:** Conseiller Keyte and the second one was ...?
