  - improvements to emergency communications, public alerting systems, and municipal websites; and
  - acquisition of equipment, software, and other resources necessary to support emergency preparedness, response, and recovery across participating Summer Villages;
- AND THAT Council authorizes the Chief Administrative Officer to collaborate with the participating Summer Villages and provide all information required for the grant application;
- AND THAT Council supports the designation of the Summer Village of Sunset Beach as the lead applicant and grant administrator responsible for submitting, managing, and reporting on the ACP Grant on behalf of the participating municipalities.
