HEREBY RELEASE, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE The participant, **JUNIOR ROUGHSTOCK ASSOCATTION/406 RODEO/JUNIOR WORLD FINALS/JUNIOR ROUGHSTOCK WORLD FINALS (PERSONAL REPRESENTATIVE, PARTNERS, AND SPONSORS)** Acknowledge that rodeo is a dangerous activity and involves RISK that may cause SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of horses, bulls, sheep and/or cattle, regardless of their training and/or past performance or any subdivision thereof, stock contractor, rodeo association, arena operators or owners, officials or any in or around the rodeo arena, promoters, sponsors, sponsoring groups, advertisers, owners and lessees of premises used to conduct the event, and each of them, their officers and employees, all for the purpose herein referred to as "releasees", from all liability to any undersigned, his/her personal representatives, assigns, heirs, and next of kin, for any loss or damage, and any claim or demands therefore an account of injury to the person or property or resulting in death of the undersigned whether caused by negligence of the releasees or otherwise, while the undersigned is in or upon the **JUNIOR ROUGHSTOCK ASSOCATTION/406 RODEO/JUNIOR WORLD FINALS/JUNIOR ROUGHSTOCK WORLD FINALS (PERSONAL REPRESENTATIVE, PARTNERS, AND SPONSORS)**, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event.

No intoxicated person may compete or participate in the rodeo event.

EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of THE STATE THE EVENT IS HOSTED IN, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
