I am writing this to express the importance the Valleyview Agricultural Society's indoor riding arena and hall that has been and continues to be such an asset to our community. I have lived most of my life in Valleyview aside from getting a university degree and returning to work here as a registered nurse. This community is such a fantastic place to raise a family. A big part of this community is the Ag society. I have learned to ride horses here and am teaching my children the joys of animals and skills of riding using the same facility I grew up in.

When I reflect on what the ag society in Valleyview is, the term 'Inclusive' comes to mind. People in any level of any discipline can come and work on their skills- specifically but not limited to horses. Because of the facility many workshops and clinics are run here. I myself have learned to rope cattle, complete in reining, work and doctor cattle, train a stock dog, even have used the facility to train for Canadian and US national championships jumping horses (even winning some). Training for excellence is a great challenge in Northern Alberta because of our weather, an indoor facility allows us to ride and host activities regardless of what the sky's are doing! Without this facility we would not attract the quality of instruction that so many great clinicians and local trainers offer.

The Valleyview Ag society is a huge supporter of 4H. 4H was a large part of my life and we used the indoor facility for riding lessons, steer show and sale, countless valuable workshops all of which I would not have had the opportunity to participate in without a facility such as this. The Hall is such a necessary part of the ag society and is used by 4H for meetings and public speaking- which is utilized by many clubs each year. It is not only the local 4H clubs that use the facility in

Valleyview but it draws interest from the entire region- hosting beef, horse, sheep, rabbit and many other regional championships and competitions.

Inclusivity does not stop with simply different disciplines of riding but with a variety of people who can use the facility. I have 3 small children who, because of this facility love to ride. In the winter we can tun on heaters to make it more comfortable for our children to both ride and watch their parents' ride. There is room for lots of horses to be tied and for spectators to watchor play! One of my daughters has Cerebral Palsy and as such needs frequent therapy to keep her muscles moving and working properly. The best therapy for this is equine. We use the facility weekly for our daughter to ride and have therapists work with her- even in the winter. I wanted to take my daughters positive experience with therapeutic riding further. I approached Cerebral Palsy Alberta about starting a riding program that could be for children with all kinds of physical, social or emotional challenges and they loved the idea. The Ag society in Valleyview was on board for this endeavor and immediately offered their facility for this program to take place. The generosity of the Ag Society will allow countless children to participate in the first ever northern Alberta adapted program that is funded through Cerebral Palsy Alberta. This program also includes parent talk sessions which can happen in the Hall portion of the arena. Looking into the future, for programs like this to continue to serve northern Alberta we will need a heated indoor riding facility to remain in our community. I look forward to using the Hall for upcoming fundraiser dinners and galas as we increase support for adapted programing in the north. The Programs Director for Cerebral Palsy Alberta has commented multiple times how supportive the Agricultural society is as there is not a single equine therapy program ran in the province with CPA due to the lack of available space, cost, willingness and volunteers.

I feel like I cannot talk about the Ag society and forget to mention the volunteers. Volunteering is just one more way the Ag society is inclusive and it attracts volunteers like no other organization! Our events are fun, well ran and well attended by people from Alberta, British Columbia and Saskachewan. Many of the volunteers for the adapted riding program are also members of the ag society- most donating not only their time but also their horses. Our community is richly blessed by the

volunteers in the ag society who put on events like Rodeos, RCMP musical rides, Fairs, horse shows, roping and jumping jackpots and fall festivals. They have jobs for 4 year old's and 94 year old's and it is so fantastic for the younger generations to be able to learn the value of volunteering. We are blessed with seniors who participate and provide invaluable support as they share their generations of wisdom and planning.

I urge you to support the Valleyview and District Agricultural Society so they can continue to encourage excellence from the ground up. I am writing this letter in support of a new indoor arena facility in ValleyView. We have rodeoed many times with high school rodeo and for WRA's there and more times than not it was in bad weather. A indoor facility would not only benefit the community during the summer on bad weather days, but it would be utilized during the winter for practices and clinics. Teepee creek is the closest Indoor arena and it is hard to book to use, as it must accommodate a large amount of people in the area. Having another option to use would really be nice. It would also be in a great centralized location with accommodations unlike Tee Pee Creek.

My son rides rough stock and he drives from Chetwynd BC to Tee Creek to practice once a month. I know that he would drive another hour just to be able to practice. My other son steer wrestles, tiedowns and team ropes. They often have practices in Teepee, but we don't go because there aren't any accommodations to stay at.

We don't have the availability up north like the southern people for places to practice at or where we can rodeo early spring because of the weather or the other in door facilities are booked up. Our high school rodeo kids only get 4 maybe 5 rodeos in, whereas in the south they get at least 6-8 rodeos. With a facility like this we could utilize it and give our cowboys and cowgirls the benefit of more rodeos, practices and clinics to learn so they can be more competitive. 



Dear Community Stakeholder,

In 1983, The Valleyview & District Ag Society, in conjunction with the Red Willow Roping Club, built the Jack Williamson Agri Plex- an indoor riding arena and meeting hall for the agricultural community. It is located on over 30 acres of land on top of Crocus Hill in Valleyview, Alberta. With the man power of local volunteers alone, a determined group of people constructed the current post frame arena. While concrete or iron footings were not affordable during that time, the current facility was constructed with hand sawed timbers. Since 1983, the arena has provided a learning and recreational facility for multi-disciplinary equine, bovine, canine and small animal use. The indoor arena and meeting hall have hosted innumerable community dances, fairs and events.

Unfortunately, time has taken its toll on the building and it is quickly coming to the end of its useful life. We have seen the steady decline of facility users. Individuals, rodeo and riding associations have given feedback that the reason for user decline is due to limited arena size, poor footing, limited seating and air quality concerns of the current arena.

Looking ahead, the Valleyview & District Ag Society is envisioning a brand-new facility for the agricultural community to enjoy for future generations. We are excited about the events and possibilities that a new and larger facility will attract and accommodate. For example, hosting a High School rodeo during the winter months is possible with sufficient arena space and spectator seating for 400 people. Events like these would certainly bolster the local economy by drawing participants and spectators from around Alberta, BC and Saskatchewan.
