If power is required, please request via your application form as spaces with access to electrical outlets is limited due to space, layout and design constraints. We will require vendors requiring power to provide their own extension cords.

Signage and Booth Decoration:

All booth signage and banners are to fit within the confines of your rented space. There are to be no materials or decorations affixed to the walls, windows, drapery or ceilings of the venue by any means including nails and tape. Failure to comply with this rule may result in an additional charge to cover damages. Signage may be affixed ONLY to the fabric covered wall spaces located against the outside walls

Set Up/ Take Down:

Set up will be Friday from 6-8 and Saturday Morning 9-10:30. Boxes, packing material and product must be out of the aisles by 10:30am.

Because this is a sponsored event, Take Down can not start until 4:00. We endeavour to have every customer that comes in, no matter how late they may arrive, have the same shopping experience! Please remember that clients are there to shop for your products!!! If you are found to be packing your table before 4:00 it will be noted and will affect your application to any future events hosted by the Valleyview Agricultural Society.
