Your Vendor applications will be reviewed. After your initial review you will receive a payment request. Payment is to be made upon receiving a request. _____(VENDOR INITIAL) All Vendors are expected to abide by Mississippi state laws at the event. This includes the consumption of illicit substances. No vendors may sell any alcohol related products. Vendors will follow all federal and state laws as well as all city ordinances. All cannabis products at the event must be 2018 Farm Bill compliant and contain less than 0.3% THC. THC-O products are strictly prohibited! Vendors will stay for the duration of the event (11-6). All vendor applications are subject to approval. Vendor Placement will be determined on a first come first serve basis. _____(VENDOR INITIAL) Vendor fees are non-refundable. Vendors are responsible for securing WIFI to collect electronic payments. Only one business allowed per vendor booth. (2) Tickets provided per vendor. Vendor Space is approximately 10x10 in size. Vendors must provide their own tent, tables and chairs, or add \$50 (table and 4 chairs). All vendors are required to tie down/secure their canopies in the event of windy weather. Tent stakes are Prohibited. (Vendors will need sandbags or equivalent to secure tents) If a vendor damages anything on premises, they will be responsible for repair costs. Vendor agrees any goods or services other than those outlined in your initial application are forbidden without the organizer's written consent. Organizers reserve the right to refuse the exhibition before or during the event of unapproved goods and/or services. _____(VENDOR INITIAL) Mississippi sales tax 7% by the State of Mississippi. All vendors must complete the MS Department of Revenue DOR Vendor Tax Form and remit payment of 7% by the end of the event. ANY vendor that does not return form and payment, WILL BE reported!! Tax payments can be paid in cash or make checks payable to: 420 Gulf Coast. Any Sales taxes questions should be directed to the Mississippi Department of Revenue. _____(VENDOR INITIAL) ALL VENDORS ARE RESPONSIBLE FOR POSSESSING CURRENT AND ACTIVE LIABILITY INSURANCE.
