AN ORDINANCE CREATING A BUDGET FOR THE VARIOUS FUNDS
FOR THE FISCAL YEAR ENDING APRIL 1, 1941.

Be it ordained by the Board of Trustees of the Town of Sugar City:

Section 1.

GENERAL FUND

12 $\frac{1}{4}$ Mill Levy, Approximately-----	\$1800.30
Franchise Privileges, Fines, Forfeitures and Licenses to be placed in the General Fund, Approximately-----	116.25
Total-----	1916.55

City Hall maintenance, Advertising and Publicity, Fire Protection, Care of Poor, Elections and Registrations, salaries of the Mayor, Trustees and Health Officer, \$55.00 per month on the Marshall's salary, \$10.00 per month on the Clerk & Water Commissioner's salary, \$2.50 per month on the Treasurer's salary and \$150.00 part payment to the State of Colorado for local liquor licenses collected for the years 1937-38-39 due the Old Age Pension Fund.

STREET FUND

Maintenance of Streets and Alleys and Street Lighting to be paid out of the Street Fund.

Repairs for Water Department, Supplies, Water Assessments, Miscellaneous labor on Water System, Electric Power Bills, \$25.00 per month on the Clerk and Water Commissioner's salary, \$2.50 per month on the Treasurer's salary, \$15.00 per month on the Marshall's salary, 75% of the yearly interest on all outstanding Town of Sugar City Ref. Bonds, 1939 series, \$1125.00 to be applied on principal payment of bonds due this fiscal year and all yearly interest due on the \$3000.00 Water Works Extension Bonds 1928 series, to be paid out of the Water Works Fund.

Section 5.

BOND & INTEREST FUND

4 Mill Levy, Approximately-----	\$ 564.80
---------------------------------	-----------

25% of the yearly interest on all outstanding Town of Sugar City Ref. Bonds, 1939 series and \$375.00 to be applied on payment of principal of said bonds due this fiscal year, to be paid out of the Bond and Interest Fund.

CONTINGENT FUND

All other miscellaneous bills not heretofore mentioned to be paid out of the Contingent Fund.
