

AN ORDINANCE CREATING A BUDGET FOR THE VARIOUS FUNDS  
FOR THE FISCAL YEAR ENDING APRIL 1, 1939.

Be it ordained by the Board of Trustees of the Town of Sugar City:

Section 1. GENERAL FUND

9 $\frac{1}{2}$ Mill Levy, Approximately-----	\$1482.48
Apportionment auto license fees, Approximately-----	107.25
Franchise Privileges, Fines, Forfeitures & Licenses to be placed in the General Fund, Approximately-----	250.00
Total-----	<u>1839.73</u>

City Hall maintenance, Advertising & Publicity, Fire Protection, Care of Poor, Elections & Registrations, Salaries of the Mayor, Trustees and Health Officer, \$55.00 per month on the Marshall's salary, \$10.00 per month on the Clerk and Water Commissioner's salary and \$2.50 per month on the Treasurer's salary to be paid out of the General Fund.

Section 2. STREET FUND

3 $\frac{1}{4}$ Mill Levy, Approximately-----	507.16
Apportionment auto license fees, Approximately-----	35.75
Total-----	<u>542.91</u>

Maintenance of Streets & Alleys and Street Lighting to be paid out of Street Fund.

Section 3. SEWER FUND

$\frac{1}{4}$ Mill Levy, Approximately-----	39.01
Apportionment auto license fees, Approximately-----	2.75
Total-----	<u>41.76</u>

Maintenance of the Sewer system to be paid out of Sewer Fund

Section 4. WATER WORKS FUND

All money to be collected from water rentals and the sale of water in any manner to be placed in the Water Works Fund, Approximately----- 3500.00

Apportionment auto license fees-----	35.75
Total-----	<u>4042.91</u>

Repairs for Water Dep't, supplies, Water Assessments, Miscellaneous labor on Water System, Electric Power Bill, \$25.00 per month on the Clerk & Water Commissioner's salary, \$15.00 per month on the Marshall's salary, \$2.50 per month on the Treasurer's salary, interest on Water Bonds and one \$1000.00 Water Bond to be paid out of the Water Works Fund.

Section 5. BOND & INTEREST FUND

8 Mill Levy, Approximately-----	1248.40
Apportionment auto license fees, Approximately-----	88.00
Total-----	<u>1336.40</u>

Interest on Sugar City Funding Bonds and one \$1000.00 Bond to be paid out of the Bond & Interest Fund.
