AN ORDINANCE CREATING A BUDGET FOR THE VARIOUS FUNDS  
FOR THE FISCAL YEAR ENDING APRIL 1, 1942.

Be it ordained by the Board of Trustees of the Town of Sugar City:

Section 1.

GENERAL FUND

12 $\frac{3}{4}$ Mill Levy, Approximately-----	\$1784.81
Franchise Privileges, Fines, Forfeitures and licenses to be placed in the General Fund, Approximately-----	142.50
Total-----	1927.31

City Hall maintenance, Advertising and Publicity, Fire Protection, Care of Poor, Elections & Registrations, salaries of the Mayor, Trustees and Health Officer, \$55.00 per month on the Marshall's salary, \$10.00 per month on the Clerk & Water Commissioner's salary, \$2.50 per month on the Treasurer's salary and \$150.00 part payment to the State of Colorado for local liquor licenses collected for the years 1937-38-39 due the Old Age Pension Fund to be paid out of the General Fund.

Repairs for Water Department, Supplies, Water Assessments, Miscellaneous labor on Water System, Electric Power Bills, \$25.00 per month on the Clerk & Water Commissioner's salary, \$2.50 per month on the Treasurer's salary, \$15.00 per month on the Marshall's salary, 75% of the yearly interest due on all outstanding Town of Sugar City Ref. Bonds, 1939 series, and \$1125.00 to be applied on principal payment of bonds due this fiscal year to be paid out of the Water Works Fund.

BOND & INTEREST FUND

3 Mill Levy, Approximately-----	\$ 419.95
---------------------------------	-----------

25% of the yearly interest on all outstanding Town of Sugar City Refunding Bonds, 1939 series and \$375.00 to be applied on payment of principal of said bonds due this fiscal year, to be paid out of the Bond & Interest Fund.
