Mission

The Stewart Community Home is committed to offering compassionate and secure housing for adults with disabilities, assisting them as they transition from homelessness or difficult situations and allowing them to realize their God given dignity to achieve relative independence, all for their well-being and the glory of God.

History

Founded in 1976 by Mrs. Sarah Stewart, The Stewart Community Home arose from her discovery of her estranged father living in dire conditions in Hogansville, Georgia. Inspired by his plight and the many others who lacked support and care, Mrs. Stewart moved her family to Columbus to create a safe haven for those in need.

Starting with eight men, the Home quickly expanded, even requiring multiple relocations and renovations to accommodate more residents. The Stewart family, deeply committed to their mission, faced financial challenges but persevered, with Mrs. Stewart balancing a job in Atlanta while nurturing the Home.

In 1989, the closed Edwina Wood School was purchased and transformed into the Home's current facility, opening in 1994. The building features dorm-style bedrooms, administrative offices, a kitchen serving three meals daily and two snacks, and communal spaces, fostering a supportive community.

Although Sarah Stewart passed away in 2018, her vision endures through her son, Dr. Harold Stewart, Jr., who remains actively involved as an emeritus board member, continuing the legacy of compassion and care.

- 91,000 lbs. of clothes are washed every year

- We average 2.5 doctor visits per day (some are drop-off appointments and some we have to sit with)
