The DNA from the alleged relative was compared to the tested child. Based on testing results obtained from the analyses of the DNA loci listed, the probability of relatedness is 1.2%. The likelihood that the alleged relative is not the biological relative of the tested child is 80 to 1. This probability of relatedness was calculated by comparing to untested, unrelated, random individuals of the Black population (assumes prior probability equals 0.50).
