**UNIFORM RENTAL AGREEMENT**

The uniform (top and bottom) you are issued are the property of the **PLAYMAKERS ELITE BASKETBALL PROGRAM**. Each basketball player issued a uniform is responsible for properly handling and caring for it throughout the duration of the rental period.

All basketball players must abide by the following terms and conditions while renting a **PLAYMAKERS ELITE BASKETBALL PROGRAM** uniform set:

1. You are responsible for any stains, tears, or other damages to the uniform while in your care and at all times.
2. You are to keep the uniform clean and in its issued condition.
3. Uniforms are to be worn for designated **PLAYMAKERS ELITE BASKETBALL PROGRAM** games/events only.
4. Do NOT alter any part of your uniform in any way.
5. Any uniform not returned by the due date and in the condition in which it was issued will be subject to a replacement fee of \$150.
6. If you quit or dismissed from the team or when the season ends, your uniform is to be turned into the coaching staff within 5 business days.

I have read and understand the above terms and conditions for renting a **PLAYMAKERS ELITE BASKETBALL PROGRAM** basketball uniform set, and I agree to abide by this Uniform Rental Agreement. I understand that if I violate these terms, I am financially responsible for any damages or loss caused up to \$150 per set issued.

**FEES and FEE PAYMENT POLICY**

Player fees are used to pay for all expenses related to the **PLAYMAKERS ELITE BASKETBALL PROGRAM** to include, but not limited to tournaments, program events, facility and equipment use, and uniform rental. The **PLAYMAKERS ELITE BASKETBALL PROGRAM** has a strict no refund policy. Why? We make a large investment into our teams and players up front at the beginning of the season and we budget pre-pay for many of our team expenses on the front end.

There are two options for paying the **PLAYMAKERS ELITE BASKETBALL PROGRAM** player fee. 100% of player fees are due by **March 1, 2024**.

If you are not able to pay your full player fees by **March 1, 2024**, you must agree to a payment plan and meet all payment plan due dates that are established by the **PLAYMAKERS ELITE BASKETBALL PROGRAM**. You can pay prior to each month that the player is participating in the **PLAYMAKERS ELITE BASKETBALL PROGRAM** or you can pay for the entire season now.

**PAYMENT PLAN TERMS AND CONDITIONS:**

1. I agree to pay all fees under the terms of the payment plan.
2. I agree to pay all my installments on time understanding that this means on or before the 1<sup>st</sup> of each month.

**LATE PAYMENT PLAN POLICY:**

After 1 week of account delinquency, I will be informed of the late fee that's due. I understand that failure to pay my fees could **IMMEDIATELY** affect my player status on the team, to include exclusion from team practices, games, and events until fee payment is received.
