Andy retired from our Board at the beginning of 2023 after 13 years of service. Andy's commitment and dedication to the LDC has left big shoes to fill.




CAROLYN BENNETT

Finally we would like to offer our deepest thanks to Rick Burrough, who retired from our Board in March of 2023. His assistance with the media will be difficult to replace.


