Official information request: the evaluation of alternative airport sites as part of Queenstown Airport Corporation's (QAC) strategic review and Master Plan process.

In the document *Queenstown Airport Master Plan Options - Let's start talking about tomorrow* it is stated that QAC has evaluated the option of moving the Queenstown airport to a new site. A summary of this evaluation is presented on pages 36 and 37.

Please supply the following information under the Local Government Official Information and Meetings Act (LGOIMA):

All and any information, correspondence, minutes of meetings, discussions, analysis and reports commissioned, used or held by QAC that contributed to and/or are a part of the evaluation that discarded the new airport strategy in favour of the dual airport strategy. This includes, but not exclusively, materials related to:

- 1. The project design and brief for the evaluation of alternative sites.
- 2. The source materials and data that were reviewed and/or collected during the research and evaluation process.
- 3. Information that outlines the rationale for selection of the initial 20 locations that were considered in the evaluation, including for example why the Cromwell/Louburn Airport was left out, and why additional greenfields sites other than Five Rivers were not considered.
- 4. The assessments made of the time and costs that would be associated with obtaining resource consents.
- 5. The detail of the evaluations and their supporting documents used to support the grading as outlined by the steps 1-4 on page 36 of the above named Master Plan.
- 6. The financial information and analysis that contributed to the evaluation, including but not limited to:
 - a. Information and reports that assess or help inform the current and future realisable marketable value of capital (land, buildings, infrastructure) currently owned by QAC within the Frankton flats.
 - b. Information and reports that assess or help inform the financial bridging costs that would be needed to cover a new site build while still operating the current site at Frankton.
 - c. The comparative financial analysis of the different possible investment pathways/options and costs between the alternatives of:

- i. the (preferred) duel airport option, using reinvestment, debt and/or new equity, relative to
- ii. a new greenfields airport, part-funded by the sale at future market values of Frankton airport land and other fixed assets.
- d. Assessment of site specific construction costs for the alternative locations.
- e. Assessment of general construction costs and build time for a new airport.
- f. Assessment of the investment required to achieve both the preferred option 2 development at Queenstown Airport plus the development of Wanaka Airport to the level needed for the projected 2 million passenger movements by the year 2045.
