- **c. Proposed Bylaws Amendment. Denise Gautreaux** reviewed the proposed amendment that was discussed, voted on and given proper notice as required by the bylaws at the last meeting. The proposed changes are as follows (CODING: Words struck through are deletions from existing document; words underscored are additions):

Article V - Duties of the Officers

Section 5: The offices of Secretary and Treasurer may be held by the same board member.

Section $\frac{5}{6}$ - All District checking and saving accounts shall require the signature of at least two (2) officers of the Board for any withdrawals.

Section 6 7- The Board shall be required to carry Directors' and Officers' Liability Insurance. The premium for such insurance shall be paid by the District.

Section \neq 8- The Board may, at its discretion, retain legal counsel to give advice and represent the District on matters of a legal nature. The services of said legal counsel shall be paid for by the District.

Section § 9- The Board may, at its discretion, retain accounting counsel to give advice and represent the District on matters of an accounting nature. At the close of each fiscal year, the books and records of the District shall be reviewed or audited in accordance with the requirements of the Louisiana Legislative Auditor. The fiscal year of the District shall be January 1 through December 31.

c. Phil Fetterman made a motion to accept the proposed bylaws amendment. **John Macus** seconded the motion. There were no objections and the motion passed unanimously.
