



TERMS AND CONDITIONS

Please read the following terms and conditions carefully. You will be unable to make any bookings or reservations unless you understand and agree to the following terms and conditions. References to “us,” “we,” and/or “our” in these booking terms shall mean Fly Girl Destinations LLC. We will rely on the authority of the person making the booking to act on behalf of any other traveler on the booking and that person will bind all such travelers to these terms and conditions.

RATES AND INCLUSIONS.

Rates

All prices and rates are subject to availability and can be withdrawn or varied without notice. The price is only guaranteed once a deposit is made. Please note that prices quoted are subject to change. Price changes may occur by reason of matters outside our control which increase the cost of the product or service. Such factors include adverse currency fluctuations, fuel surcharges, taxes and airfare increase. Please contact Fly Girl Destinations LLC directly for up-to-date prices.

Quotes “Three Free”

Quotes are only valid for 24-hours, rates are subject to change after this period has passed. Additional quotes are available through Fly Girl Destinations LLC. You are allotted to three free quotes prior to booking. After you have exceeded three free quotes, additional quotes are available for \$50 USD to be paid directly to Fly Girl Destinations LLC.

Roommates and Room Pairings

All bookings will include hotel and resort stay arrangements unless expressly stated otherwise or requested. Hotel rooms are typically booked with two individuals assigned to each room at the time of booking. Should you require a deviation from this, then notify your travel agent at the time of booking. In the event that your party has an uneven number of travelers, your travel agent may attempt to place you with a roommate at your request. DEPOSIT AND PAYMENT TERMS.

At the time of booking reservations, a non-refundable deposit per person is due to Fly Girl Destinations LLC. If reservations are made 45 days or less prior to departure, the full amount will be due at the time of booking. Should you make your reservation more than 45 days in advance, payment plan options are available. However, the full amount of your reservation will be due 45 days prior to your departure.

Payments by Credit Cards

In case of making the deposits or payments by credit cards, as a traveler or participant, you agree and accept full responsibility for payments made. Fly Girl Destinations LLC will not be held accountable for any amount that is chargeback or disputed. All chargebacks or disputed amounts must be paid back to Fly Girl Destinations LLC promptly to ensure your booking is not cancelled. All major credit cards are accepted.

DETAILS REQUIRED FOR BOOKING.

As a condition of booking, you must provide the information requested by Fly Girl Destinations LLC along with final payment. Should you fail to supply information required by Fly Girl Destinations LLC for air tickets, permits, or other inclusions, you will also be liable for any costs, fees or losses including failure to obtain or provide that inclusion. REVISIONS, DEVIATIONS, AND CANCELLATION FEES.

Revisions

Any changes made to the individual booking will be subject to the current prices and rates of booking. If there is a decrease in price, then that amount will be credited back to the individual in the form of a trip credit for future travel use.



Deviations

We aim to operate all tours as advertised but as we plan the tours many months in advance, we may occasionally have to make changes or cancel your booking and we reserve the right to do so at any time.

Changes: If we make an insignificant change to your tour, we will make reasonable efforts to inform you as soon as reasonably possible if there is time before your departure, but we will have no liability to you. Occasionally we may have to make a significant change to your confirmed arrangements. We will notify you if it is necessary to make a significant change.

Cancellation Fees

A cancellation fee will apply and will be due immediately upon cancellation in the amount of \$100 per booking. This fee applies when a booking is cancelled for lack of payment, change of mind, medical reason, and/or any reason not specified unless a new trip is booked immediately upon cancellation.

REFUNDS.

Refunds are available to individuals that purchase travel insurance in the form of a travel credit unless explicitly stated otherwise by the vendor.

Generally, no refund or reduction will be made to any member in respect of airfare, accommodation, meals, sightseeing tours, transport or any other services which are included in the booking not utilized by the individual due to personal reasons.
