DYNAMIC DARU

His new life from May 2021 to present

Daru (Hungarian for white crane) was the 11th and last puppy of our E litter, delivered by C-section on March 22, 2016, tipping the scale at over 10 oz. Parents were our Buda and our Zenta. He had a wonderful time with us and his litter mates before driving off with his new owner, Sue, to Texas, in style - in a sporty BMW, to spend the next 5 years in his new home.

In April 2021, we were notified that Daru was losing his owner due to terminal cancer. We immediately said we would take him back.

Various rescues took care of placing Sue's cattle dogs and sheep, and local HPCA members stepped in to take care of the 8 Pumik. 2 puppies had Parvo, so all the adult Pumik had to be quarantined for 2 weeks. Sadly, the puppies didn't make it, but all the adults were fine. When Daru was finally released from quarantine, in May, Meir drove 8 hours from SC to Mississippi, to meet up with two of the rescue crew, Sandy Cumpian and Cameron Collier who kindly transported him, driving 8 hours from Texas. In the morning, Meir drove home with Daru and an Anatolian Shepherd going back to her breeder in NC.

Daru remembered Meir as soon as he saw him and wagged his tail for the first time in quite a while. Daru had seen us in Texas at Pumifest, a couple of years before and spent a week with his brother Csoban (sharing a room during Eukanuba in Orlando) when he was a puppy. The trip home was uneventful. Meir arrived home at nightfall, so after a few hugs, Daru had to go to sleep in a new crate away from the other dogs and us until we could assess his condition. He was not in great shape. He was thin. His white hair was dirty and matted, some 6-8 inches long. He couldn't see well through all the mats hanging in front of his face. I don't think he had been groomed in over a year.

First thing next morning, I shaved him, expecting to find maggots but his skin was fine. After a nice bath, he was a new man! He remembered the house and where his nursery had been. It was like he never left. The years between nursery and adult melted away.

My agility instructor didn't have a beginner class until August, so I started his training at home. He took to it right away surprising me with his love of the weaves and everything else. Meir took him herding the first week he was home and he loved that, too.

All was well on the home front, except that his father, Buda, and brother, Csoban wanted to kill him so there was and still is a lot of management and stress for us as well as Daru, who is very sweet. He loves people and all dogs. He plays well with Asztro and all the girls, so we have to switch outdoor play times throughout the day.

His first agility trial was in December at Clemson, 4 months after his first lesson and he did well, even getting a 2nd place Q in std. He had a wonderful time. He is now in Open in both JWW and Std.

Meir kept training Daru in herding, and he earned his first titles in both AKC (Pre-Trial Test on sheep) last month, and 3 AHBA Junior Herding Dog titles (on sheep, goats, and turkeys), just before last year's Pumifest. Last weekend, Daru moved up to Masters Rally (he earned his Excellent title over Memorial Day) where he got 2 Q's, and a qualifying leg in Novice obedience, a work in progress. We are taking the summer off from agility class and trials to work on dock diving, which he seems to love.

Daru is a joy! He is cuddled up next to me, on the bed, as I write secure in the knowledge that he is home. He had a rough year before he came back to us, but his spirit and playfulness remain intact. His is calm, gentle, and polite. He has a zest for life and loves everything we do with him. Welcome home Daru!
