From AKC Regulations: **Lure Coursing, Coursing Ability and Fast Cat (page 41)**

SECTION 13. COLLARS/PARAPHERNALIA. Dogs may wear any type of collar except choker collars, a collar with prongs or an electronic training collar. The collar should be snug to minimize the chances of catching on something during the run. Clubs may, at their option, require that tags hanging from the collar be taped up. Owners may have their dog wear a muzzle if they desire. Owners may use clips or rubber bands to hold the dog's hair. The owner assumes responsibility of the safety of the dog with regard to the dog's collar and paraphernalia on the dog. Head halters, such as the Gentle leader or Halti, may be used on the grounds but must not be worn while running the course.

Lessons learned by diving in headfirst at my first Fast CAT Trial in Perry, Georgia.

Fast CAT (Coursing Ability Test) is a lot of fun for both you and your dog! To make it even more fun, prior to entering and running, I suggest reading the Regulations, or at bare minimum at least watch a run or two before signing up and attempting. Going into a Trial with another newbie, one who has talked with a few people and run their dog a time or two is an experience but not for those easily discouraged.

REMEMBER THIS: The most important thing to have in your corner is a dog with a GREAT recall!

Familiarize yourself with the entry form and the information provided in the Trial Premium. Know the height of your dog; do not rely on an official to perform measurement. Have cash in your pocket or checkbook handy; not everyone has Square attached to their cell phone. Understand that the coursing machine is very loud, so if your dog is sound sensitive maybe just hang out, meet some of the competitors, pick up some tips.

Be sure to have an allowed collar. I spent a LOT of time unsuccessfully attempting to remove name and rabies tag from Huba's collar. We ended up swapping collars with Jasper. A major complication was with the leash. The dog is led into the "box" and released. A snap leash or even a slip lead is beyond difficult for the handler. Unless that person is willing to improvise it is just cumbersome.

It takes two people to have a successful run. A "holder" and a "catcher".

The "holder" if it is not you, should know your dog; or be somewhat accomplished at wrangling. The dog must move into the "box" and wait for the "tally ho" signal. At release your dog should "chase" the lure. In my case, Huba exited the box and went on an adventure to locate me. Twenty or more people calling your dog's name does little to capture the errant canine. The result was a 1st one hundred yard run that was off course and didn't count for anything but a good time. To reiterate you'll want a great recall!

The most stressful part was leaving my dog and walking one hundred yards to the catch area, to the end of the course. Huba was stressed, not being familiar with his holder and not a big fan of whirring noise. Our first Trial was one of experience gained and lessons learned. Our second Trial was much better resulting in a faster run.

I've joined a FaceBook Group dedicated to Fast CAT. I've purchased a coursing leash/collar from BIF Blankets & Leads (UDBASENJI@COX.NET). I'm reading the AKC Regulation book (pdf from AKC website). I will go into my next Fast CAT Trial better prepared and much more aware of what is expected.

It will be such fun as Pumik gather in Concord, NC for the Magnolia Pumi Club Specialty Shows and hopefully competing at the Fast CAT Trials too.

How to Make Eggshells Powder

When prepared correctly, eggshell powder is considered safe. Nevertheless, there are a couple of points to consider:

First, do not feed large fragments of eggshell as they might injure your dog's throat and oesophagus. The next paragraph will give you a few tips on how to grind eggshells into powder.

Second, eggshells may be contaminated with bacteria, such as *Salmonella enteritidis*. When baking eggshells at 100°C (200°F) the Salmonella bacteria are destroyed – however, if you prefer an extra layer of safety you can boil the eggshells before baking them. Boiling them can lead to loss of part of the calcium content so only steep for a few minutes.

Quick & Easy Eggshell Powder

You can either make your own eggshell supplements at home or buy pre-made eggshell powder in health food shops / online.

Eggshell powder can be made at home using a pestle and mortar or, for a finer powder, a coffee grinder. Just be sure to crush the eggshells into powder or very small fragments before feeding them.

- 1 Rinse the shells.
You can save them in the fridge for a few days or in the freezer for longer until you have collected the desired amount of eggshells.
- 2 If necessary defrost the shells.
If necessary boil the eggshells for a few minutes (optional).
Preheat the oven at 100°C (200°F).

- 3 Place your eggshells on a baking tray and bake them for 20-40 mins (depending on how wet the shells were when placed in the oven).
- 4 Once completely dry and crispy remove them from the oven.
- 5 If you're using a coffee grinder, make sure it's clean before grinding the eggshells (you don't want any bits of coffee to mix in the eggshell powder). Grind the eggshells until all large pieces are ground to a powder. If you don't have a coffee grinder, a mortar and pestle is also a good way to grind to a powder

INGREDIENTS

- 2 cups whole wheat flour
- 1 cup oats
- 3/4 cup natural peanut butter make sure it does not contain xylitol
- 1 large egg
- 1 1/4 cups hot water

INSTRUCTIONS

- Preheat oven to 350 Degrees F.
- In a large bowl, combine all ingredients and stir to mix. The dough is thick, and you may find that you need to use your hands to actually knead the dough together.
- Roll into balls approximately 1" in diameter and place onto a baking sheet. Using the tines of a fork, gently press a crosshatch shape into each cookie. This will both give a physical imprint of lines and help flatten the cookie dough.
- Bake for 15 minutes, then remove from oven and place baking sheet on a wire cooling rack. After ten minutes, remove from baking sheet. Store tightly covered.

NOTES

Storage: Make sure to completely store treats before storing. Once cool, store in an airtight container or freezer bag. I recommend then storing them in the fridge for 7-10 days, or freezing for up to two months. At room temperature they are fine for 3-4 day
