The undersigned agrees to the following stipulations and conditions:

1. Vendors are responsible for obtaining all permits necessary for conducting their business off-premise.
2. THAT Sports Bar shall not be responsible for fire, theft, injury or legal action that should arise on the premises during the time occupied according to this agreement.
3. Vendors will be accepted in order of application receipt. Only one vendor of each type will be allowed (wine, cookies, jewelry, etc). Total number of vendors admitted will be up to the sole discretion of THAT Sports Bar.
4. The fee for a 10x10 space is 10% of sales.
5. A \$50 non-refundable deposit is due upon notification of application acceptance and must be paid prior to **Friday, February 28th, 2020**. An electronic invoice will be generated and sent to the email address on the application. This deposit will be deducted from the 10% vendor fee.
6. Subleasing of space is forbidden.
7. Vendors are responsible for providing all required tables, chairs, tents, electronic devices (POS, Square Readers, etc) and extension cords for their space. Free Wi-fi is available at THAT Sports Bar, however the range and bandwidth may be limited during the event due to the number of attendees, so plan accordingly.
8. There is no extra charge for electricity, however you **MUST** indicate whether you require electricity for your space so that we can assign you a location with access to electricity. There are only so many spaces with electricity available, so if electricity is not required, please indicate no.
9. Space set-up is Saturday from 12 p.m. to 2:30 p.m and Sunday from 10 a.m. to 11:30 a.m. **No early set up is allowed. Early departure is prohibited without prior approval from event coordinator (Danielle Hoffman) and vendors must check-out with event coordinator prior to leaving each day. Violations of this rule will result in the vendor being banned from future events hosted by THAT Sports Bar.** Merchandise can be left overnight at vendor's risk. No overnight security will be provided. A limited number of one-day spots may be available at the last minute, at the discretion of the THAT Sports Bar.
10. Applications are due by **Friday, February 14th, 2020**. Any applications received after that date may be returned if no openings are available.
