PUMPER PULL RULES:

- 1) Teams must consist of five individuals. Teams may be unisex. Teams are open to everyone.
- 2) Teams will pull a fire engine a designated distance for time. Team time determines advancement and placement.
- 3) There will be two timers. Each team will pull twice, the best time will be taken. In the case of a tie, there will be a pull off of the two teams tied (only for 1st, 2nd or 3rd).
- 4) Teams must wear tennis shoes.
- 5) Each team captain must check in the day of the event between 12:00 pm - 1:00 pm at the event site. Team captains are responsible for ensuring a complete team. **1:45 pm will be the forfeit time and team will not be refunded entry fee.**
- 6) There will be a mandatory rule meeting at 1:30 pm prior to the start of the competition. **All team members must be present for the meeting.**
- 7) Final decision on payout will be decided upon the number of teams entered on the day of the event.
- 8) **Competition will commence at 2:00 pm on Saturday March 14, 2020.**

ENTRY FORM INSTRUCTIONS:

- 1) Each team must name on Team Captain. The team captain will identify teams. The team captain should submit one registration from the entire team.
- 2) Each team member must sign the "GENERAL RELEASE OF LIABILITY" form.
- 3) The entry fee for the Boone County Pumper Pull 2020 is \$30 / team on or before March 13, 2020. Registration on March 14, 2015 is \$50 / team.
- 4) Registration is limited to the first 20 teams that submit form and payment. **Registration will be taken up until 1:00 pm on March 14, 2015. All teams must be paid in full before competition begins.**
