### **Notice of 2024 Membership and Registration**

The 2023 memberships will expire on 31 December 2023 and the followings about the 2024 membership and competition fee has been confirmed:

### **Membership Fee for 2024**

Individual Member who is aged 18 or above HK\$300 Affiliated Club Member HK\$1000

For those age under 18 will not be accepted to be the member of the Association, in which they are just required to submit HK\$100 registration fee and become eligible to participate in specific local competitions, relevant certificate courses and different activities are solely organized by Association. If any person who has attained the age of 18 in 2024 and wishes to apply for membership will be entitled to a deduction of HK\$100 for the membership fee of HK\$300 if he has paid the registration fee for 2024.

All new and existing individual or affiliated club members must complete the application form for the 2024 membership and affix a recent photo (For application for the individual membership only) together with appropriate documents, the crossed cheque and **an addressed envelope with HK\$2.2 stamp** to our office for processing or you can visit our office for the application during the office hours. Payment by cheque, the crossed cheque made payable to "Hong Kong Fencing Association". Please be reminded that endorse the cheque with your name/the name of the body corporate and contact number.

According to the Article of Association, the authorized number of member is fixed at 3,000, including Individual and Affiliated Club Members, and the period of validity of the membership is from 1 January 2024 to 31 December 2024.
