Applying or Renewing License for International Competitions

In view of that many fencers have to apply certain licenses for competitions sanctioned by various confederations, including the International Fencing Federation (FIE), the Fencing Confederation of Asian (FCA) and the European Fencing Confederation (EFC). As all licenses are required to be applied for by the Association and the information on each license is as follows:

	Validity	Fee (included the admin charge)
FIE License	Starting after the World Fencing Championships (WFC) in each year and ending with the WFC in next year	HKD 300
FCA License	Starting after the Asian Junior & Cadet Fencing Championships (AJCFC) in each year and ending with the AJCFC in next year	HKD 200
EFC License	Starting after the World Fencing Championships (WFC) in each year and ending with the WFC in next year	HKD 300

In order to simplify the application process for each member and the registered fencer, each person only needs to fill in the following reply slip and return it to the Association with a **recent photo** and **relevant fee**. Should there any payment by cheque, the crossed cheque should be made payable to "Hong Kong Fencing Association" and please be reminded that endorse the cheque with your name and contact number.
