What We Can Do to Help

Information Session – An in-person presentation/lecture that describes the entire surrogacy process, the participants, your role in it, costs, and possible options with associated advantages and risks, and Q & A.

Customized Plan – We start with multiple interviews. Using the results, we formulate a plan for the entire process, start-to-finish. This will be a step-by-step guide to help you accomplish your goal in the most efficient way possible with greatest odds of success.

Weekly meetings - A 30-minute weekly meeting to check on status, resolve issues and plan for the week ahead.

Project Plan – This is like the Customized Plan, but at a deeper level, down to individual task. If you have ever worked with a professional project manager you will be familiar with the process. We will develop a schedule down to the day of completion.

Project Management – A 60-minute weekly meeting. The Project Plan is reviewed, risks and issues are resolved, and adjustments are made to the plan if necessary.

24/7 Support – We will be available for you any time of day or week to help and/or support you during the process.

Administrative Support – There is a mountain of paperwork involved in this process: contracts, payment agreements, travel arrangements, insurance, reimbursements, and more. We take on the responsibility of filling out those forms and delivering them where needed. Your role is just review, signature and payments when needed. This will be a substantial time-saver. Additionally, our experience may help surface important items in the agreements that might have overlooked.

Travel and Lodging – Intended Parents, Providers and Surrogate are often not located near each other physically. Travel and Lodging are almost always required multiple times during the process, particularly with our Cross-State Surrogacy® program. We arrange all necessary travel and lodging – visits to providers, lodging as needed, housing for the surrogate, etc. as well as all required transportation.

Payments – You will make a one-time payment at the start of the process, which will be placed into an escrow account. We will make withdrawals from that account to pay all the fees associated with the surrogacy process – legal, medical, surrogate, etc. There will be complete transparency – you will be aware of every step we take.

Provider Search and Recommendation – if you are missing one or more pieces of your support team – a lawyer, an IVF provider, a surrogacy agency, etc. – we will conduct a search for you to find the right provider to meet your specialized needs. We have a group of trusted partners for each category, but if none of them prove to be the right match, we'll go outside of the group to find you what you need.

Surrogate Search – This is probably the most important person you're going to work with in your entire life. You Just Cannot Get This Wrong! We will conduct a search nationwide for the right candidate. We will conduct background checks, medical and psychological tests, and anything else needed. We also provide any support, physical or emotional, that the Surrogate may need during the process.
