# • Committee Report: Special Education Parent Committee

- Andrea Levy, Chair, provided updates on the committee's activities and purpose.

# Updates & Discussion with the Deans!

- Cassandra Heifetz (Dean, Lower School) and Jackie DeLucia (Acting Dean, Upper School) discussed the FY25 MCPS Proposed Operating Budget for MVA.
- Deans encouraged families & staff to provide their input to the Board of Education.
- Discussion included reduction of staffing, including administration, teachers, and other staff. Current plan suggests having one Dean (Cassandra Heifetz) and one Supervisor (Jackie DeLucia) for both upper school and lower school.
- Funding from ESSR is being discontinued. There are increases in the MVA budget & MCPS is showing a commitment to funding the MVA. 149.7 positions are funded for next year.
- BOE hearing is scheduled for: Tue, January 30 Operating Budget Work Session #3
- Projected enrollment for 2024-2025 (enrollment waitlist still open, 85% of current families recommitted) - 2nd-12th - about a similar enrollment as this current school year.
- Nancy Perry (5th Grade), elected facility staff representative presented on advocacy:
  She discussed a 50% cut in administration. Discussed that the MVA administrators

are involved with school improvement plans, master schedule, teachers, parents and students have what they need and much more. Teachers are concerned that the reduction of administrative staff will impact them. Would like to maintain the same administrative staff structure. They are writing to the school board, superintendent, etc. Julia Rogers (Upper School) discussed advocacy to call, write letters and talk to the Board of Education through public comments. - Ms. Heifetz commented in chat "Middle school brick and mortar allocations for admin: 1.0 FTE per school. Schools projected to have 650 or more students receive a second assistant principal. Every effort is made not to remove the second assistant principal one year and have to restore it the next year and maintain administrative stability. If a school has a coordinator, subtract 1.0 FTE from this allocation."
- Ms. Heifetz also commented "For HS: 1 Principal PLUS 2.0 Assistant Principals per school ≥ 3000 receive an additional 4.0 FTE 2550–2999 receive an additional 3.0 FTE, 2130–2549 receive an additional 2.0 FTE and 1600–2129 receive an additional 1.0 FTE."
