### **PTAs**

### Pros:

Already established national organization with EIN, bylaw templates/requirements, training for officers. Legal framework exists.

Strong lobbying group with MCPS, State and Nationally

Some tools like MemberHub available.

Insurance is at a negotiated group rate.

#### Cons:

Pay large amount of dues to local, state and National PTA organizations. (\$5+ per membership)

Follow their rules, bylaws and procedures.

Concerned if they will fairly represent Virtual Academy.

Politics with the local, state and national PTA may mean little benefit to unique needs of Virtual Academy community.

### **PTOs**

### Pros:

Independent organization where all funds stay within the organization to serve its purpose.

We choose to advocate directly for Virtual Academy and student/staff needs.

More flexibility in terms of what we can help fund (i.e. more like a booster club vs. PTA).

Own By-Laws, EIN, and non-profit status.

Avoid the issues going on within the PTA organization.

#### Cons:

Have to create and maintain our own bylaws, EIN and procedures. Have to complete state and federal paperwork to form a non-profit.

Negotiate our own insurance.

Excluded from PTA programs, such as the Reflections Program and other competitions for the students.

## **Informal Group**

### Pros:

No PTA/PTO politics.

Parents can informally take on roles of interest to support the school.

No pressure to fundraise to meet minimum expenses - insurance, website, etc.

#### Cons:

No structure so parents have to organize themselves each year.

Without non-profit status, collecting money/fundraising becomes very difficult. Many donors/outside supporters and activities require status.

Can be chaotic and difficult for interested families to participate in if there isn't an organization with centralized communication and helping to connect people with similar interests/goals for the organization

No insurance, which may be a liability issue for any activities held.

How will fundraising and money be handled? E.g. If individuals do it, it will be income to them personally on their tax return, and without nonprofit status it cannot be a tax write off.

### **Bank Account**

The PTO needs a **nonprofit checking account** to be an organization that can receive proceeds e.g. from a dine-out night or selling school shirts, instead of having individual parents handle funds that cannot be pooled in one place for the PTO to then purchase things e.g. after school club/activity funds. This enables the organization's funds to stay with the members on the PTO to the benefit of the students.

Paypal account to be set up to make online transactions easier. We will need to check Venmo rules to see if they allow non-profits/PTO's.

### **Insurance**

Really needed before handling money and hosting activities. Coverage is for liability, accidents, activities and events (e.g. after school clubs, dine out nights, walk-a-thon), and officer liability.

It appears our primary options are AIM, RVNUCCIO and PTO Today.

Cost from AIM and Rvnccio are about \$400.

Next step: Review quotes and coverage; may be needed before PTO activities start.
