Silver State Service Dogs Coronavirus Policy

What is Coronavirus? Coronavirus (COVID-19) is an illness caused by a virus that can spread from participant to participant. COVID-19 symptoms can range from mild (or no symptoms) to severe illness. Common symptoms include coughing, fever, shortness of breath or difficulty breathing, fatigue, and headaches. Symptoms may appear 2-14 days after exposure to the virus. Due to the extremity of this virus, we ask that SSSD members abide by certain guidelines in order to protect everyone in our organization including our service dogs.

Silver State Service Dogs COVID-19 Policy:

- I. **Wear a mask properly during SSSD meetings.** The CDC recommends that one washes their hands prior to putting on a face mask, wearing it over the nose and mouth, securing it under the chin, fitting it snugly against the sides of the face, and ensuring that one can breathe properly. We ask that SSSD members wear face masks as the CDC states that they are effective in preventing the spread of COVID-19. Face coverings are required indoors in Nevada.
- II. If possible, **stay a distance of 6 feet apart from one another in enclosed spaces.** We are aware that this is not always possible, but we ask that SSSD members attempt to do so and keep distancing in mind.
- III. **Do not attend meetings or training if you have any symptoms of COVID-19.** SSSD is made up of many people who are at a heightened risk of infection, and we cannot risk spreading the virus. If you are feeling ill, we kindly request that you stay home. If you have strong symptoms of COVID-19 or believe that you have been exposed, please contact Diane Villa and inform her of your possible exposure. We will need to inform the team, but your name or personal information will not be disclosed.
