CODE ENFORCEMENT CODE COMPLIANCE

Enforcing the Town codes and ordinances affect the quality of life in the Town of Pierce. Code enforcement protects the safety and well-being of the public. We suggest you take time to get to know the Town codes. Code enforcement involves officials ensuring compliance with policies, codes, rules, regulations, and permits in a timely fashion. Town codes are adopted by your Board of Trustees, then enforced by staff.

The process for Code Enforcement is both proactive and reactive. Code enforcement is also complaint driven. Every complaint is investigated. When a warning is issued, it will detail the number of days given to correct the violation. A warning is NOT a citation. A summons to court may be issued, if the Municipal Court Attorney feels the violation is enforceable in a court of law. The Town may also have staff correct the violation. If this happens, the property owner or tenant will receive a bill from the Town.

What Is Fentanyl?

Fentanyl is a potent synthetic opioid drug approved by the Food and Drug Administration for use as an analgesic (pain relief) and anesthetic. It is approximately 100 times more potent than morphine and 50 times more potent than heroin as an analgesic.

Fentanyl is a Schedule II narcotic under the United States Controlled Substances Act of 1970.

More recently, there has been a re-emergence of trafficking, distribution, and abuse of illicitly produced fentanyl and fentanyl analogues with an associated dramatic increase in overdose fatalities. Do NOT touch Fentanyl!



How Much Fentanyl Can Kill You?

The lethal amount of fentanyl is next to the penny above.
