VEHICLE GUIDELINES

The Technical Committee has been asked by the Board of Directors to establish guidelines for an acceptable automobile as described in the Bylaws. The following are recommendation made by the Technical Committee.

BODY: The body should remain primarily unmodified. Non-original period accessories such as continental kits or fender skirts, etc., are allowable additions.

PAINT: The colors do not have to be original. It should, however, be done either in a period correct manner or tastefully done as a period modified.

CHROME: Bumpers and stock chrome should remain primarily intact. Personalized changes may be acceptable if approved by the Technical Committee.

INTERIOR: The interior should be as original as possible. The material may be non-original. Safety items such as seatbelts are accepted and encouraged. Add-on air conditioning and sound systems are also acceptable.

TIRES AND WHEELS: Not restricted as to style and type. Dimensions should remain close to original.

ENGINE COMPARTMENT: Engine and engine compartment may be non-original as long as the vehicle meets all other specifications.

SUSPENSION: Not restricted. Upgraded suspension, brakes and steering to enhance ride, stability and safety are allowable. Other modifications may be made to the vehicle to suit the personal taste and desire of the individual owner. All applicant vehicles must be at least twenty-five (25) years old and are subject to approval by the Technical Committee. Vehicles include automobiles, trucks and motorcycles.
