EIGHTH AMENDMENT TO THE PEPPERRIDGE OF WILDWOOD CONDOMINIUM DECLARATION OF CONDOMINIUM OWNERSHIP AND BY-LAWS OF PEPPERRIDGE OF WILDWOOD CONDOMINIUM OWNERS' ASSOCIATION

WHEREAS, the PepperRidge of Wildwood Condominium Declaration of Condominium Ownership was recorded on August 26, 1983 in Deed Book 1475, Page 70 of the Official Records of Butler County, Ohio ("Declaration"); and

WHEREAS, the Bylaws of PepperRidge of Wildwood Condominium Owners' Association, Inc. ("By-Laws") was attached to the Declaration as "Exhibit C" and recorded along with the Declaration on August 26, 1983 in Deed Book 1475, Page 135; and

WHEREAS, the First Amendment to the Declaration of Condominium Ownership was recorded in Official Record Book 1482, Page 244 of the Butler County, Ohio Recorder's Office on November 22, 1983; and

WHEREAS, the Second Amendment to the Declaration of Condominium Ownership was recorded in Official Record Book 1486, Page 45 of the Butler County, Ohio Recorder's Office on January 9, 1984; and

WHEREAS, the Third Amendment to the Declaration of Condominium Ownership was recorded in Official Record Book 1491, Page 552 of the Butler County, Ohio Recorder's Office on April 3, 1984; and

WHEREAS, the Fourth Amendment to the Declaration of Condominium Ownership is dated May 25 1984 and was recorded in Official Record Book 1496, Page 399 of the Butler County, Ohio Recorder's Office; and

WHEREAS, the Fifth Amendment to the Declaration of Condominium Ownership was recorded in Official Record Book 1502, Page 216 of the Butler County, Ohio Recorder's Office on August 1, 1984; and

WHEREAS, the Sixth Amendment to the Declaration of Condominium Ownership was recorded in Official Record Book 1506, Page 226 of the Butler County, Ohio Recorder's Office on September 20, 1984; and

WHEREAS, the Seventh Amendment to the Declaration of Condominium Ownership was recorded in Official Record Book 1637, Page 704 of the Butler County, Ohio Recorder's Office on July 15, 1988; and

WHEREAS, another amendment to the Declaration, also titled the Seventh Amendment to the Declaration of Condominium Ownership, was recorded in Official Record Book 7664, Page 2115 of the Butler County, Ohio Recorder's Office on November 29, 2005; and

WHEREAS, the Declaration, By-Laws, and all Amendments thereto are binding upon the Units described in Exhibit A hereto; and

WHEREAS, Article XII of the Declaration provides that the Declaration and By-Laws may be amended by filing for record with the Recorder of Butler County, Ohio of an instrument in writing setting forth the items to be amended and any new matter to be added and approved by seventy-five percent (75%) of the total voting power of the Association; and

WHEREAS, Article XII of the Declaration provides that any amendment to the Declaration must be approved by the Eligible Mortgage Holders; and

WHEREAS, Section 8.1.2 of the By-Laws defines an "Eligible Mortgage Holder" as those holders of a first mortgage on a Unit that have requested, in writing, that the Association notify them of any proposed action that requires the consent of a specified percentage of eligible mortgage holders; and

WHEREAS, no mortgage holder has sent a written request pursuant to Section 8.1.2 of the By-Laws and, as such, there are no Eligible Mortgage Holders as certified by the Affidavit of the President of the Association attached hereto Exhibit B; and

WHEREAS, at least seventy-five percent (75%) of the Unit Owners have signed this Seventeenth Amendment as evidenced by certification contained in the Affidavit of the President of the Association attached hereto as Exhibit B;

NOW, THEREFORE, the By-Laws are amended as follows:

1. The following shall be added to the By-Laws as Section 6.10(r):

Section 6.10 <u>Authority of the Board</u>. In addition to the powers set forth above, the Association, through the Board of Directors, may exercise all powers of the Association, including the power to do the following:

(r) Borrow money and assign the Association's rights to assessments, or other future income, to a lender as security for a loan to the Association.

Except as amended herein, the Declaration and By-Laws remain in full force and effect
