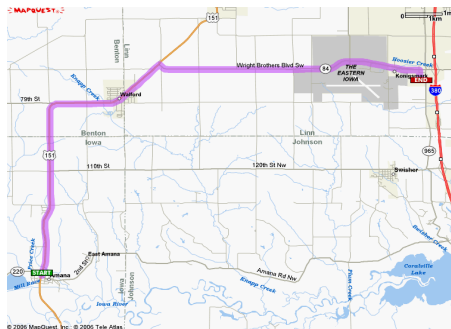

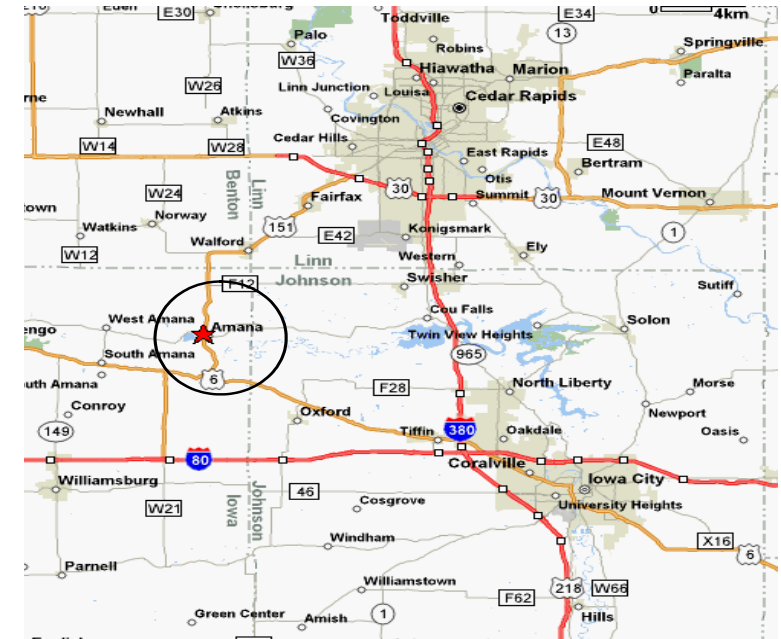

Entry confirmation will be sent (via e-mail, unless you request otherwise) as soon as possible after the closing date. **ENTRY FEES SHALL NOT BE REFUNDED** in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

**BITCHES IN SEASON** (on the date of the show) are not permitted to compete. Refunds less \$5 administrative fee per class entered per day will be made for bitches that come in season after the closing date for the trial. Written Notification to claim refund must be received by the Secretary by Friday, April 5 2024.

**NO REFUND FOR DUPLICATE ENTRIES.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made. Refunds of \$3.00 & less will not be issued due to the costs of processing.

**ERRORS ON ENTRY FORMS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES** except when being judged. **ABSOLUTELY NO DOGS** off leash at any time on Convention Center grounds per AKC and Convention Center rules.

**CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that Show is over, and the Secretary advised at once. The Secretary and show-giving Club disclaim any liability for Cash prizes after the judging of the class is over.

**ALL TROPHIES** must be claimed at the show. If not, they become the property of the Show Giving Club. **NO TROPHIES** will be mailed.

**IOWA CITY DOG OBEDIENCE CLUB RESERVES THE RIGHT** to substitute trophies with ones of equal or greater value.

**ALL VIDEOTAPING** during the Show requires Club permission.

**Any exhibitor arguing with show officials or exhibiting unsportsmanlike behavior will be subject to Event Committee Jurisdiction.**

## ATTENTION: JUMP HEIGHT REQUIRED ON ENTRY FORM!

Per Chapter 1, Section 3 of the AKC Obedience Regulations amended June 2008 and effective January 1, 2016, entries must include a jump height to be acceptable.

**OBEDIENCE entries in the classes that use jumps Open, Utility, Graduate Novice, Graduate Open, Versatility, must include a jump height on the entry form in order to be a valid entry, obedience entries WILL be arranged by jump height (small to tall) at these trials.**

I (we) acknowledge that the "Rules Applying to Registration and Dog Shows" and, if this entry is for an obedience trial, the "Obedience Regulations," have been made available to me (us), and that I am (we are) familiar with their contents. I (we) agree to hold the AKC and any AKC approved judge harmless from any legal claim resulting from said AKC judge's action under the AKC Rules, Regulations and Guidelines.

I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or Trial Secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. **Instructions**

- 1 (Variety) If you are entering a dog of a breed in which there are varieties for show purposes please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color) Beagles (not exceeding 13 in.; over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Fox Terriers (smooth, wire), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list.
