THE SHOW SITE WILL BE AVAILABLE TO EXHIBITORS BEGINNING AT 7 AM FRIDAY, APRIL 7, 2023. NO DOGS MAY REMAIN IN THE BUILDING OVERNIGHT. All dogs and equipment MUST be removed immediately after completion of all judging on Sunday. Chapter 2, Section 26 of the Obedience Regulations will be enforced at these shows.

PRE-PAID CATALOGS may be picked up at the Trial Secretary's table. A limited number of catalogs will be available for purchase at the trials for \$5 per copy.

ALL VIDEOTAPING during the Show requires Club permission.

Time: 30 minutes following end of trial each day

Format: 5 minutes ring time for \$5. Entries will be accepted during the day of the trial and close each day at the start of the Match and no entries will be accepted after that time. Three rings will be available and 25 runs/ring will be accepted. Second runs will take place after first runs are completed. Toys and food may be used as well as verbal corrections and gently guiding the dog, Training collars (prong or electronic) are not allowed (per AKC regulations for OC Matches).

Directions to the show

From I-80, go North on Hwy 151 at exit #225 to Amana, IA. The Convention Center and RV park are in the northwest quadrant at the intersection of Hwy 151 and 220. Enter the grounds from C Street.

From I-380, take Hwy 30 west to Hwy 151. Go south to Amana, IA. Enter the grounds from C Street.
