So, moms, dads, grandparents, aunts, and uncles; dress up your Lil' Wrangler in western attire and start snapping those cameras. **NEW:** Pictures can be taken either at the Lil' Red Barn display on the front porch of the Expo & Convention Center on the fairgrounds OR any western background of your choice.

- 1) There will be four age categories:
 0-6 months
 7-11 months
 12-23 months
 2-3 years old (must not be older than 3 by Sept. 1)
- 2) **Siblings category. Can be any number of siblings of any age.**
- 3) Pictures can be taken either at the Lil' Red Barn display on the front porch of the Expo & Convention Center on the fairgrounds OR any western background of your choice beginning Monday, September 13th and ending Sunday, October 3rd. **NO professional photographers allowed.** Only one baby or toddler allowed in each photo except in Sibling category.
- 4) Photo must not be larger than a 5x7. Photo and entry forms must be turned into the fair office by 5:00 p.m. on Monday, October 4th with a \$15.00 entry fee **per photo.** **No entries accepted without fee.** There will be no limit on photos entered.
- 5) Photos with results will be displayed in the Exposition & Convention Center during the fair.
- 6) Photos and awards may be picked up at the Fair Office beginning Monday, October 18th. Awards not picked up by October 29, 2021 will be forfeited.
- 7) The winners in each age category will receive the following:

1st Place: \$75 & ribbon **2nd Place: \$50 & ribbon** **3rd Place: \$25 & ribbon**
