ENTRY INFORMATION

- All departments are color coded as follows:
 4-H Junior/Junior FFA Green
 4-H Senior/FCCLA/Senior FFA Pink
 Open Youth Yellow
 Open Adult Lilac
 Flower Show Blue
 Fine Arts Coral
 TEEA Light Blue
- 2. All Exhibitors must be permanent residents of Austin County or enrolled in a public school, private school, or home school in Austin County or enrolled in elementary, junior high or high school during the 2023/2024 school year.



3. All entry cards and tags are available at the Austin County Fair Office (979-865-5995) and the Austin County Extension Office (979-865-2072). There is an explanation powerpoint to provide guidance on completing entry cards and tags.

- 4. All articles entered must be labeled with the appropriate tag. The tag must contain the classification of article and name of article. Entry cards must be completed by the exhibitor and have the appropriate signature for the youth division. No multiple participant entries allowed. Only single participant entry accepted unless otherwise designated.
- DO NOT MIX CATEGORIES. PLACE ONE CATEGORY ON A CARD. (Example all category A items on one card.) Only one item per class (Ex. A1).
- 6. All entries must be made from November 2023 thru October 2024.
 - They must be in excellent condition, very clean, well pressed, and odor free or they will not be accepted.
 - All exhibits must be made by the exhibitor, and only one entry per class will be accepted.

• It is unethical to exhibit items that have been previously exhibited or made by anyone other than the exhibitor.

Division chairmen have the authority and responsibility to disqualify items that are deemed inappropriate, dirty/washed, soiled or do not appear to have been made or completed in the last year or previously exhibited.

- 7. NO duplicate items will be accepted in miscellaneous categories. Items may be entered as miscellaneous only if they do not qualify in listed classes.
- 8. Exhibitor information must be completed on EACH entry card. All exhibitors are required to place a daytime cell phone number and email address on entry cards.



No crafts or recipes may show or contain any Alcohol or references to Alcohol.

- 10. Due to limited display space, items should not measure larger than 30 inches wide by 30 inches high unless foldable for display. Any questions, please call the phone number listed as the point of contact per department or the Austin County Fair Office at 979-865-5995.
- 11. New this year, Categories are marked Eligible or Ineligible for Youth Supreme & Country Auction sale lots.

- 1. All articles will be accepted on Monday, October 7, 2024 from 4:00 p.m. to 6:45 pm and Tuesday, October 8, 2024 from 9:00 am 11:45 am.
- 2. Although precautions will be taken, the Austin County Fair Association and volunteers will not be responsible for items lost, stolen or broken.
- 3. It is encouraged for all items to be tagged and properly labeled before entrance into the exhibit building.

CHECK OUT PROCEDURES

1. Items on display in the exhibition hall will not be released until 11:00 am on Sunday, October 13, 2024. In addition, all items left after 2:00 p.m. on the date of check out will no longer be the responsibility of the Austin County Fair or its affiliated partners.

Items removed prior to scheduled removal time will forfeit all prize money. Exhibitors are welcome to recycle any ribbons or rosettes if they so desire.

2. All exhibit prize money must be collected between 11:00 and 2:00 p.m. on Sunday, October 13, 2024 at the EXPO CENTER. After Sunday, prize money can be picked up at the fair office. Money not picked up by November 1, 2024 will be forfeited.

SCORING

1. Judging will begin at 1:00 p.m. on Tuesday, October 8, 2024 for all categories.

- Exhibits will be scored as follows: Grand Champion 500 points; Reserve Champion 300 points; Blue Ribbon 100 points; Red Ribbon 90 points. Prize money will be paid as follows: Grand Champion \$15 Reserve Champion \$10; Blue Ribbon \$1.25; Red Ribbon \$.75.
- One (1) Grand Champion entry and one (1) Reserve Champion entry may be selected from each category in each division in each department if warranted by the judges.
 Please note that each <u>Category</u> must have four (4) or more items to be awarded Grand or Reserve Champion.

4. The judge's decision is final.

- 5. Judges are requested to write a comment on back of tag when awarding a red ribbon.
- Grand Champion and Reserve Champion exhibitors only will have the opportunity to **DONATE** their prize-winning exhibits to the sale on Saturday afternoon. Proceeds from **DONATED** Grand and Reserve Champion items will go to the Austin County Fair Association.
- 7. Donating to the auction is optional and failure to donate does not forfeit the exhibitor's rosette or prize money. Note: Due to the sentimental or personal value of items, exhibitors may decline including their entries in the auction.

All Donated Grand Champion and Reserve Champion baked foods must be baked fresh for Saturday. **Baked goods must be delivered to the fairgrounds by 9:00 am on Saturday.**

YOUTH DEPARTMENT RULES & AWARDS

San Bernard Electric Cooperative will award trophies to High Point Exhibitors in each division in the **4-H Junior, Junior FFA, Open Youth, Senior 4-H, FCCLA,** and **Senior FFA Departments.** <u>An</u> <u>exhibitor may receive only one trophy per year.</u> Trophies for each specific division (canned foods, baked goods, clothing, home improvement, flower show and photography) will be awarded to the same individual only once. In case of a tie, the winner will be determined by the number of his/her Grand, Reserve, blue, red ribbons and the total number of entries. If a tie remains, the final tie breaker will be a flip of the coin.

A monetary award will be given to the Overall High Point Exhibitors. Three awards will be made: 1st Place - \$50; 2nd Place - \$30; 3rd Place - \$20. Overall high point exhibitors may receive the first-place award only once. Youth Supreme Auction Rules

Rules for entering items in the Home Economics departments can be found under the General Rules. Rules for specific categories can be found under the specific Division. All rules listed in the General and Youth Department rules must be abided to in order to participate in the Youth Supreme & Country Auction.

Judging Process for Home Economics

- Individual Items will be judged in their specific category individually and will receive a blue ribbon.
- Please note that each Category must have four (4) or more items to be awarded Grand or Reserve Champions.
- Next, Categories will be judged to choose a Grand and Reserve Champions. There can be multiple winners in the same Division depending on the Categories.

Winners will receive prize money and a rosette, \$15.00 for Grand and \$10.00 for Reserve.

- Division Grand Champions will be judged for Supreme.
- Exhibitors winning Supreme will receive a banner and the opportunity to sell in the Youth Supreme & Country Auction
- Exhibitors will be notified by phone and/or email and asked if they want the opportunity to sell in the sale. Please provide a good adult cell phone number and email address on your entry card.
- Participating in the Youth Supreme & Country Auction Sale is highly encouraged but is not mandatory. The decision is up to the exhibitor in the case of sentimental value of the entry.
- Exhibitors will be allowed to sell in both the Youth Livestock (Friday) and the Youth Supreme & Country Auction (Saturday).
- In the case of Baked Goods, items must be baked fresh in the specified quantities for the Auction on Saturday, Oct 12. Please deliver to the fairgrounds by 9 am to be sold as a whole item.
 - Breads One (1) Whole or two (2) dozen
 - Cakes One (1) Whole or two (2) dozen
 - Cookies Two (2) Dozen
 - Candy Two (2) Dozen or Equivalent to 24 pieces
 - Pies One (1) Whole pie
 - Baked goods will need to be provided in an appropriate decorative non-returnable container.

Eligibility for Participation in the Youth Supreme Sale

- All entries will be exhibited and sold by their owners unless he/she is physically unable to do so due to a medical condition. The ONLY permissible excuses for "physically unable to do so "are a DOCUMENTED medical or family emergency and /or a DOCUMENTED and sanctioned school function of which the exhibitor must PARTICIPATE. Exhibits to be shown or sold by someone else other than the owner must be approved in writing by the respective committee chairman. It is the responsibility of the exhibitor to obtain and complete the required form. Forms will be available at the Fair Office.
- If an exhibitor is Academically Ineligible to show, the exhibitor AND THEIR PROJECT are ineligible to participate in the Austin County Fair.
- Eligibility of Exhibitors earning Supreme will be verified by the specified District Adjunct Representative or Facility Representative. In the case of Open Youth Exhibitors, they will need to provide a copy of their current progress report.
- There will be a 7% fee deducted from the Exhibitors check for ACF accounting purposes.
- Handwritten "thank you" notes will be required for Buyers and for any additional add-ons provided. A list of Thank you notes will be mailed to you.
- Checks will be distributed to Exhibitors when all checks are ready for distribution and upon receipt of a handwritten Thank you note in accordance with the Youth Auction Sale/Add-On Check policy.
- In order to cash the Youth Supreme Auction checks, the EXHIBITOR must endorse the check. Exhibitors will have 30 days after checks are printed to turn in thank you notes and pick up checks. After this time period, the Sale and Add-On monies will go to the Austin County Fair Scholarship fund.
- Exhibitors will be required to submit a completed W-9 form for tax purposes.
- Exhibitor and one (1) parent will be asked to work during the Youth Supreme & Country Auction sale or volunteer to help with the Check out process on Sunday, October 13, 2024 at 9 a.m.

Based on the recommendations of Ball Canning, the following criteria applies. The level of jar contents must be ¹/₄" to ¹/₂" from the top of the jar lid. Low acid canned food items (items in pressure canner) need to have 1" head-space. All canned foods do not need a label, just an entry tag. All jars must be clean and shiny with rings. Canning can be done in only a standard canning jar (Mason, Ball, Kerr, etc.) – salad dressing or other such jars are not allowed. Fruit, vegetables, fruit pickles, and vegetable pickles – pieces in jars should be uniform in size and product should not be floating. Jelly must be firm, but not hard or with visible sugar crystals. It must pull away clean from the side of the jar and still hold its shape. Fruit or vegetable juice must be bright and have a clear color. It should not be cloudy. Quality canned items do not have air pockets or bubbles among the vegetable or fruit pieces. **Please note that each Category must have four (4) or more items to be awarded Grand or Reserve Champions.**

CANNED FOODS DIVISION

All canned foods do not need a label, just an entry tag. Based on the recommendations of Ball's canning, the level of jar contents must be $\frac{1}{4}$ to $\frac{1}{2}$ " from the top of the jar lid. Low acid canned food items (items in pressure canner) need to have 1" head-space. All jars must be clean and shiny **with rings**. Canning can be done in only a standard canning jar (Mason, Ball, Kerr, etc.) – salad dressing or other such jars are not allowed. Fruit, vegetables, fruit pickles and vegetable pickles – pieces in jars should be uniform in size and product should not be floating. Jelly must be firm, with no visible sugar crystals. It must pull away clean from the side of the jar and still hold its shape. Fruit or vegetable juice must be bright and have a clear color. It should not be cloudy. Quality canned items do not

have air pockets or bubbles among the vegetable or fruit pieces. . Please note that each Category must have four (4) or more items to be awarded Grand or Reserve Champions.

- 3. All artwork submitted must have been made since November 2023.
- 4. Only one (1) piece of artwork per person will be accepted per group.
- 5. Academic eligibility will be verified by each district Art teacher.
- 6. All exhibits in this department must be labeled, Exhibitor name, address/school, exhibitor division, Title, phone number and email address.
- 7. The Art Chairman reserves the right to disqualify duplicate pieces.
- 8. Exhibitor divisions are:
 Open: Adult (non-professional)
 Youth: Elementary, Junior High and High School
 School Art: Elementary, Junior High and High School

"BE CREATIVE AND ORIGINAL IN COMPOSITION AND IN EXPRESSION."

9. Entry Regulations: NO Plagiarism allowed! Published images MAY NOT be reproduced in whole or part. Published images include, but are not limited to, drawings, sketches or photographs published electronically (eBooks, mobile apps, web sites, etc.) or in print (magazines, books, brochures, etc.). No trademark logos, licensed characters or any other copyrighted image. However, any listed may be used as reference material.

No obscenity allowed!

No profane references to a deity, obscene language, drug abuse or paraphernalia, images that are violent or any content that may offend the moral standards of the community.

10. Acceptable medium:

Pencils (graphite, colored, charcoal), pressed crayon, pastels (chalk, oil), paints (tempera, acrylic, watercolors, oil), inks (pen & ink, printmaking, sgraffito), paper (collage). **All loose materials must be 'fixed' with a spray fixative*.

11. Size of Work:

Adult, High School, Junior High ages – maximum overall dimensions of mounted artwork cannot exceed 24" x 24". Example: Mount the 22 x 22 art piece including the 1" border cannot exceed 24 x 24.

Elementary artwork cannot exceed 9"x12"; mounted with no more than a 1" border (example: mount the 9" x 12" art piece on a 11 x 14 is the equivalent size to $\frac{1}{2}$ sheet of poster board, the final measurement)

- Artwork must be mounted or matted with white or black mounts/mats; no liners or additional inner mats allowed. <u>Un-mounted artwork will not be accepted</u>.
- 13. All artwork MUST to be unframed. <u>Canvas board/stretched</u> <u>canvas artwork MUST have a tab attached to each top corner</u> so that the artwork can be hung on the display board before arrival.
- 14. Do not put your signature on the front of your artwork.

- 15. Each school district will be permitted to enter a maximum of twenty (20) or less best pieces of work from the High School Division and a maximum of twenty (20) or less best pieces of work from the Junior High Division. At the Elementary level each district may submit a maximum of (20) or less pieces.
- 16. For Private or Coop Home Schoolers to be entered under School Art, campus may have a maximum of twenty (20) pieces of artwork.
- 17. Individual Home School Exhibitors will enter in the open division.
- 18. Students work must be teacher "verified". This means that all work submitted must be created by the student under the teacher's observation. If an Exhibitor is instructed by a private teacher each piece must be different.
- All work submitted by teachers will be picked up by teachers and released to the student at school. Pick up for Open Youth and Open Adult is 10:00 am to 11:00 am.
- 20. Awards:

Elementary School Art: (K-5th)

One (1) "Best of Show" and one (1) "Honorable Mention" rosette will be awarded per campus. The remaining entries will receive participation ribbons. Prize money: "Best of Show" receives \$10.00 and "Honorable Mention" receives \$5.00.

Junior High School Art: (6th -8th)

One (1) "Best of Show" and one (1) "Honorable Mention" rosette will be awarded per campus. Judges will award blue and red ribbons based on merit. Prize money: "Best of Show" receives \$10.00 and "Honorable Mention" receives \$5.00. No prize money will be awarded for blue and red ribbons.

High School Art: (9th -12th)

One (1) "Best of Show" and one (1) "Honorable Mention" rosette will be awarded per campus. Judges will award blue and red ribbons based on merit. Prize money: "Best of Show" receives \$10.00 and "Honorable Mention" receives \$5.00. No prize money will be awarded for blue and red ribbons.

Open Youth: (K-12)

One (1) "Best of Show" and one (1) "Honorable Mention" rosette will be awarded. Judges will award blue and red ribbons based on merit. Prize money: "Best of Show" receives \$10.00 and "Honorable Mention" receives \$5.00. Prize money will be awarded for blue and red ribbons.

There will be a Supreme Best of Show Champion chosen from High School, Junior High, Elementary and Open Youth to be included in the Youth Supreme & Country Auction on Saturday, October 12, 2024. Art chosen for the sale will be displayed in a designated area. Supreme Youth Best of Show is encouraged to provide a frame with or without a mat to complete the piece for the Youth Supreme Sale.

Open Adult:

EXHIBITORS MAY BE:

- Group I Any adult citizen of Austin County and not an owner of a nursery or floral shop.
- Group II Students of Austin County in grades Kindergarten through 12 are eligible to enter in the Open Flower Show Youth Division and are eligible to be awarded ribbons, trophies or prize money. Austin County Clover Kids, 4-H, Junior and Senior FFA and FCCLA members may enter the Open Flower Show Youth Division but are not eligible for ribbons, trophies or prize money. Please note there is a division for these groups where you are eligible for awards.
- Group III Any commercial owners of a nursery, floral shop or floral designer who perform their duties in a professional capacity.

RULES AND REGULATIONS

- Entries will be accepted on Monday, October 7, 2024, from 4:00 p.m. until 6:45 p.m. or Tuesday, October 8, 2024 from 9:00 am until 11:45 am.
- Exhibits must remain in place until noon. on Sunday, October 13, 2024. PLEASE DO NOT REQUEST EARLY REMOVAL OF AN EXHIBIT.
- 3. Number of entries is limited to a total of ten (10) per person. In the Horticulture Division, an exhibitor may enter only one exhibit per variety in a class. Example: under hybrid tea roses, one Tropicana, one Peace, one Chrysler Imperial, etc. may be entered as long as each exhibit is a different variety.
- 4. ENTRY FEE: An entry fee of \$3.00 will be charged per item.

- 7. Horticulture exhibits must have been in the exhibitor's possession for at least 90 days and exhibits must be established in show containers at least 60 days.
- 8. Entry cards may be obtained in advance from committee members or the Fair Office at the fairgrounds in Bellville. They are to be completed in advance, if possible, and each exhibitor is required to sign the exhibit card before the exhibit is entered or placed.
- 9. Care will be taken in having exhibits observed during the fair to prevent unnecessary damage to exhibits. However, each exhibitor is to take the responsibility to give his/her exhibit any care or water that he/she deems necessary during the display times.

CLASS 15 – AFRICAN VIOLETS

FRUITS AND VEGETABLES ARE TO BE DISPLAYED ON AN APPROPRIATELY SIZED DISPOSABLE PLATE. EXCEPT FOR MELONS, FOR WHICH NO PLATE IS REQUIRED. THE FOLLOWING QUANITIES ARE REQUIRED FOR JUDGING PURPOSES:

CLASS 16 – FRUITS (DISPLAY ON APPROPRIATE SIZE PAPER PLATE) – Minimum of 3 pieces per entry per item Watermelon quantity one (1) will be accepted.

CLASS 17 – VEGETABLES (DISPLAY ON APPROPRIATE SIZE PAPER PLATE)- Minimum of 3 pieces per entry per item

MAY BE EXHIBITED IN EITHER A CLEAN POT OR HANGING CONTAINER APPROPRIATE FOR THE PLANT OR AS A SPECIMEN.

CLASS 18 – HERBS Potted or Specimen

COUNTRY STORE RULES AND REGULATIONS

- 1. An individual must enter competition in the Home Economics Division of the Austin County Fair. Rules and regulations of the exhibitor's corresponding department will be followed with special rules for baked goods and canned goods.
- 2. NO COMMERCIAL EXHIBITORS ALLOWED. All items entered for sale must be **made by the exhibitor**. Items listed in the official 2024 Austin County Fair Home Economics Catalog may be used for a guide.
- 3. Handcrafted items entered for sale in the Country Store will not be judged and will not receive ribbons. Premium money will not be paid for these items. Items entered in the baked goods division by ADULT exhibitors may be brought to the Country Store to sell.
- 4. Sale items may be entered the same days as all other exhibits of the EXPO CENTER, as well as during Country Store hours.
- 5. Baked goods may be entered the first Monday, Tuesday, Wednesday, Thursday, Friday and Saturday during Country Store hours. Any perishable baked goods not sold or picked up may be discarded at the close of the second day of exhibition.
- 6. All canned goods and baked items are to be labeled ON THE ITEM as well as the sale tag. Canned items are to have been prepared within the last year only using standard canning jars and must be secured with rings.
- 7. Exhibitors must complete their own sale items on a yellow sale card and individual yellow sale tags. The following information is required on the sale tags.
 - A. Exhibitor's number (same as used in competition)
 - B. Item number (as listed on sale card)
 - C. Brief item description (ex. pink bib)
 - D. Name

E. Sale price (Twenty percent of the sale price will go to the Austin County Fair Association. For sales totaling over \$500, the Austin County Fair Association will receive thirty percent.)

The numbers of the sale items and the sale card must correspond and be legible. A minimum price of \$1.00 will be charged per item and pricing must be done in increments of fifty cents.

- 8. Exhibitors will be asked to work the equivalent of four hours in the Country Store. If an exhibitor is unable to fulfill this duty, he/she must find a substitute.
- 9. The Country Store will be open as follows:

- 10. Items not sold should be picked up between 2:00 p.m. 3:00 p.m. on Sunday, October 13, 2024.
- 11. All money for sale items will be mailed to exhibitors within thirty (30) days.
- 12. The Austin County Fair Association and volunteers will not be responsible for items lost, damaged or stolen.

FLORAL DESIGN COMPETITION

The Floral Design Competition is open to Juniors (3-8 grade) and Seniors (9-12 grade). The format allows single entry or teams of 2 exhibitors each to compete on Thursday, October 3, 2024. A maximum of 20 Teams/Single Exhibitors. **Entries will be accepted online with payment on the Austin County Fair website.** This will be considered an Austin County Fair project. Questions may be emailed directly to <u>austincofloraldesign@gmail.com</u>. **Entry fees are nonrefundable and non-transferable**.

Competition Format: Each individual/team will compete in the design and execution of a fresh floral arrangement centerpiece and table design, which may include but is not limited to such items as dishes, napkins, additional table coverings, etc. Exhibitors must be in the same age category.

Design Guidelines: Each individual/team should review the design guidelines prior to the Floral Design competition. Exhibitors will have one hour to execute their design.

- All elements of the entry should reflect or enhance the contest theme. This year's theme will be announced on the Austin County Fair website. Please go to https://austincountyfair.com/floral-design for the theme for this year's contest.
- Entries are arrangements of fresh floral cut materials and design elements that fit the theme and your design concept.
- All cut materials and table design elements will be provided by the Exhibitor.
- Each exhibitor will be furnished with a workstation, table and tablecloth.
- Entries will be displayed on a 36" round table with a black table covering. The exhibitor is responsible for positioning all

elements of their design on the table. Exhibitors are required to use the table covering provided by the Show.

- Entry should be designed to be VIEWED FROM ALL SIDES.
- Each exhibitor must bring their own tools and flowers. Tools/Flowers cannot be shared by exhibitors/teams.
- No Advance preparation. Foam will be soaked during orientation.
- Fresh flowers only. Small dry accents can be used (ex. wheat, lotus pods, and cotton)
- Exhibitors are required to bring two (2) copies of their Record book in a folder day of competition. This form can be found online on the floral design page on the ACF website.

Permissible tools include:

Wire cutters	Knife
Floral Tape(s)	Measuring stick
Floral cutters	Wrapped Wires

JUDGING: The show will select qualified judges for each competitive event. Any questions about the judging criteria may be directed to a committee member.

Judging will be based on the following seven categories:

- Design Aesthetics Line/Form, Color, and Space
- Design Principles Balance, Proportion, and Unity
- Mechanics Creative Engineering of Mechanics Proper Coverage of Foam, and Sturdiness of Design
- Execution Neatness and Cleanliness of overall Design,
- Creativity Uniqueness of Design, Use of Theme
- Teamwork
- Record Book

Only judges and Committee members will be allowed inside the competition area while judging is in progress.

No cell phones, watches, ear buds or any type of communication devices are permitted during the competition. Any exhibitor found communicating with anyone outside of the competition could result in immediate disqualification.

Talking or gestures from outside the barrier will not be tolerated and result in immediate disqualification.

Judges' decisions are final.

Winning entries will be announced on Thursday, October 3, 2024, after the competition is complete.

Floral Design entries will not be included in the Youth Supreme & Country Auction.

Additional Opportunity: Any Floral Design pieces placing 3rd on may be entered into the 4H/FFA/FCCLA Junior or Senior Flower Show. Entry cards are available at the Expo Center on the day of entry. There is a power point online under Home Economics to help explain the entry procedure. There is a charge on \$3.00 per entry. Team pieces will be entered by a designated exhibitor. Exhibitors are encouraged to exhibit in the 4H/FFA/FCCLA/Open Flower Show using any additional product they may have left over Exhibits must not exceed 30" W x 30" D. These arrangements will not be eligible for the Youth Supreme and Country Auction sale.

Entries must be picked-up by 2:00pm on Sunday, October 13, 2024.

Fair Cup Competition

The Fair Cup competition is an individual exhibitor competition to be held on Thursday, October 3, 2024. A maximum of 40 Exhibitors, Juniors $(3^{rd} - 8^{th})$ and Seniors $(9^{th} - 12^{th})$ may participate in the Fair Cup Competition. Entries will be accepted online with payment on the Austin County Fair website. Entry fees are nonrefundable and are non-transferable. This will be considered an Austin County Fair project. Questions may be emailed directly to austincofloraldesign@gmail.com. Entry fees are nonrefundable and non-transferable.

Competition Format: Each exhibitor will compete in the design and execution of a floral arrangement.

Design Guidelines: Each exhibitor should review the design guidelines prior to the competition. Exhibitors will also have an opportunity to ask questions at the mandatory pre-event meeting.

- Exhibitors will have one hour to plan and execute their design.
- All materials will be provided by the Fair.
- Exhibitors MUST utilize items provided. Each exhibitor will be furnished with materials, including fresh flowers, foliage, container, and decorative elements. The flowers, foliage, and supplies will be the same for each exhibitor.
- Each exhibitor will receive the same type of decorative elements, but the design of each element can be different amongst exhibitors. The exhibitor is responsible for determining which materials they will use in the design of their entry.
- Entries will be displayed on eight-foot tables with a black table covering. The exhibitor is responsible for positioning all

elements of their design in the required location on the table. No outside adornments are allowed.

- All elements of the entry should reflect or enhance the theme which will be revealed prior to the fair. Each exhibitor's design will be a sole effort with no assistance from anyone in any manner.
- No cell phones, watches or other communication devices are allowed in the competition area during the competition.
- Any communication with another person outside the barrier will not be tolerated and may result in immediate disqualification from competition.
- Entry should be designed to be VIEWED FROM ALL SIDES.
- No paints, ribbons, or decorative accessories of any kind may be supplied by the exhibitor. Only the materials supplied by the fair will be allowed.
- Each exhibitor must bring their own tools. Tools cannot be shared by exhibitors.
- Permissible tools include: Floral Glue(s) Scissors Wire cutters Knife Floral Tape(s) Measuring stick Floral cutters Wrapped Wires Wired Wood Picks Floral Wire
- Participants in the Fair Cup competition must check in on and attend the mandatory meeting held prior to the competition; competition will begin immediately after the meeting.
- Judging will begin during the competition as well as immediately after all exhibitors have completed their design and will be based on the following four categories:
- Design Aesthetics, Line/Form, Color, and Space.
- Design Principles Balance, Proportion, and Unity.
- Mechanics/Execution Neatness and cleanliness of design, proper coverage of foam and sturdiness of design.
- Creativity inspiration with theme and container as well as usage of materials.
- Each exhibitor may receive a copy of their score sheet following the competition.

- Only Fair Cup Floral Design Competition judges, and Committee members, will be allowed inside the competition area while judging is in process.
- Judges' decisions are final.
- Buckles will be awarded to the Grand and Reserve Champion exhibitors immediately following the conclusion of judging.

SUPREME FAIR CUP

Exhibitors placing Supreme Champion will have the option to create a silk arrangement to enter into the Youth Supreme & Country Auction to be held on Saturday, October 12, 2024.

The Floral Design Committee will provide all of the materials for this entry. The committee will coordinate with the exhibitor to complete the entry and have it on display the week of the fair in the Youth Supreme designated area.

Supreme Champions will receive the auction price minus the reserve to cover the materials and the administrative fee from the fair. See the Youth Supreme & Country Auction section of this book for a full set of rules pertaining to the auction.

Buyers will pick up their purchase at the conclusion of the auction.

Miniscapes Competition

The Miniscape Competition is open to individuals or teams of two exhibitors who will come to Austin County Fairgrounds on Sunday, September 29, 2024. Check in begins at 8:30 am with design and execution between 10 a.m. until 12 noon. to create their competition entry. Check in and installation must be complete by noon. **Please join the ACF Horticulture page on Facebook.**

The contest will be split between Junior and Senior entries at the discretion of the Horticulture Committee. Junior are 3rd to 8th grade and Senior are 9th to 12th grade. It is Mandatory to register via the online sign up form on the ACF website/Menu/Horticulture. Entries will be the first twenty-four (24) exhibitors based on forms received via online entry with any additional entries being added to a waiting list.

The Horticulture Committee will confirm your entry via email. <u>Exhibitors will be required to RSVP by September 1, 2024 to</u> <u>confirm they will be participating at the fair.</u> If exhibitors fails to respond, an individual or team will be pulled up from the waiting list, tracked via entries and email. This rule has been put in place to avoid No-SHOW entries and for the maximum number of Exhibitors the opportunity to participate. Entries will close upon limitations or no later than August 5, 2024.

Competition Format: Each individual/team will compete in a design and execution of a Miniscape, based on the **theme to be released on the ACF website prior to entries opening online**.

Design Guidelines: Exhibitors should review the guidelines prior to preparing their entry. Questions may be directed to the Horticulture Committee at ACFHorticulture@gmail.com.

- Entries will be constructed in a water trough (planter) that is approximately 24" deep.
- Troughs will be chosen on a First Come First Serve Basis
- Troughs vary in sizes by 24 X 48, and 22 X 46 inches, please plan accordingly.
- The planter will be provided by the Fair.
- Each planter will be pre-filled will soil up to the top of the planter.

- Plant materials should be able to withstand sunny, warm conditions.
- Planters will be displayed outside for 15 days.
- No living creatures may be used in the design.
- Entries should be designed to be viewed from all sides.
- Entries may not display signage that names the team's school, school district or FFA/4-H chapter. A sign will be provided upon completion of judging for display on the grounds.
- Exhibitors are responsible for bringing wagons, carts, wheelbarrows, etc. to transport their materials from the parking lot to the exhibit area.
- Exhibitors can get in line starting at 8:45 am. Entry to the competition area will begin at 9 am. Troughs will be chosen First Come First Serve.

Day of Competition:



- Check in for Miniscapes will be on the grounds of Austin County Fair on Sunday September 29, 2024, starting at 8:30 am. Each team will receive a registration number. No one will be allowed in the design area until 9 am.
- Announcements and introduction of judges begins at 9:45 am
- Competition begins at 10:00 am
- Designs must be complete by Noon.
- Exhibitors will be met by the Horticulture Committee volunteers; the volunteers will assist with check in, direct the exhibitors to the exhibit area.
- Parents and adult leaders may assist with moving in supplies and planter materials to the competition area but must vacate the area prior to commencement of the contest.
- Carts/wagons are recommended for transporting materials from a vehicle to the competition area.
- The planting and design of the planter must be performed by the exhibitors ONLY.
- No cell phones, iPads, Watches, or any other type of communication device is allowed in the competition area.
- Paper sketches of design are allowed in the competition area.
- The exhibitor is responsible for providing the plants and any props to be used in the planter.

- The exhibitor is responsible for bringing all tools needed to prepare their planter.
- Buckets will be provided for each team to use for holding purposes while the design is being planted. Any extra soil not used can be left in the supplied buckets and the Horticulture committee will keep for reuse.
- Trash Containers will be provided for each team to clean up their area and throw all trash away when planting is complete. Brooms and dustpans will be available to sweep your area.
- Each Exhibitor will write a Thank you note to our sponsors on the day of the competition to be turned in prior to award announcements. All materials will be provided by the committee.



- Unsportsman like conduct will not be tolerated. If there are instances by exhibitors or parents, the exhibitor will not be allowed to participate the following year.
- Entries will be watered and maintained by the Horticulture committee during the following weeks.
- Exhibitors will have access to water and watering pitchers on that day and must water their troughs thoroughly before leaving.
- The Show is not responsible for lost, damaged or dead items.
- Items of great sentimental value should not be used.
- It is MANDATORY to remove all design elements and plants including any type of stones or other types of hardscape used in your design on Sunday, October 13, 2024 by 3 pm. No Exceptions.

Judging: The fair will select qualified judges for each competitive event. Any questions about the judging criteria may be directed to the Horticulture Committee.

- Entries will be judged on a 100-point system:
 - Up to 50 points may be awarded for design.
 - Up to 30 points may be awarded for staging and quality.
 - Up to 20 points may be awarded for variety of plants.

Each team must be prepared to explain to the judges what their plant choices are and how their design fits the theme during the competition.

- Winning entries will be announced on September 29, 2024, and winning exhibitors will be recognized at 2:00 pm
- <u>Judges' decisions are final. Please feel free to talk with</u> judges after the competition is over to get their thoughts and ideas for your design and scores.

Awards: Supreme Grand Champions will receive a banner. Buckles will be awarded to the Grand and Reserve Grand Champion winners in both Junior and Senior Divisions. Placement ribbons will be awarded to all exhibitors.

SUPREME MINISCAPES

A Supreme Champion will be chosen from the Grand Champions in the Junior and Senior Miniscape Division. Supreme Champions will have the option to enter their Miniscape into the Youth Supreme & Country Auction to be held on Saturday, October 13, 2024.

Supreme Champions of the Miniscape Division will have the option to sell and will receive the auction price minus the reserve to cover the trough, soil and the administrative fee from the fair. See the Youth Supreme & Country Auction section of this book for a full set of rules pertaining to the auction.

Exhibitors will surrender all items used in their Miniscape as designed. **Items of great sentimental value should not be used**. Buyers will pick up their purchase on Sunday morning at the conclusion of fair.

Removal: Exhibitors placing other than Supreme, **MUST REMOVE** their plants, stones and design materials on Sunday, October 13th from noon to 3 pm. **Any plants or materials left after 3 pm will be disposed of or become the property of Austin County Fair**. Containers will be moved to their storage location.

Container Plant Competition

The Container Plant Competition is open to individual exhibitors who will come to Austin County Fairgrounds on Sunday, September 29, 2024, between 9 am and 10 am to submit their competition entry. Check in is at 9 am. Entries will be completed and accepted via online entry. **Entries will close on August 5, 2024.** One entry per exhibitor. Entry fees are non-refundable. This will be considered an Austin County Fair project. Please see the ACF website for the updates or additional details5 under Menu/Horticulture.

There are two Divisions in Container Plants, Juniors and Seniors. Junior are 3rd to 8th grade and Senior are 9th to 12th grade. Entry for Container Plants is located online at the ACF website/Menu/Horticulture and is Mandatory for entry submittal. **The Horticulture Committee will confirm your entry via email.** <u>Exhibitors will be required to RSVP by September 1, 2024, to</u> <u>confirm they will be participating at the fair.</u>

Competition Format: Exhibitors will plant and cultivate 3 or more different plant species in an appropriate container. Each project will have a corresponding project log to be submitted with the entry at check in.

General Guidelines: Exhibitors should review the guidelines prior to preparing their entry. Questions may be directed to the Horticulture Committee at email address ACFHorticulture@gmail.com.



- There is NO Theme for Container Plant entries.
- Entries must have been owned and grown by the exhibitor for at least 8 weeks prior to the Show. (Planted NLT August 7th)
- Plants should show evidence of being grown in the container, such as being securely rooted in the soil.
- If plants are found to have been freshly potted or do not stand up during the Show because they were not potted soon enough, entries will be disqualified.
- If single elements require replanting during the eight-week period prior to the Show, the exhibitor should document (in writing and with photos) the removed element and the replacement element. The documentation will be part of the

Exhibitor Project Log. (See the "Exhibitor Project Log" section below).

- Do not put Exhibitors name on the Cover of the Project log
- Entries should be complete upon arrival to the Show.
- Entries must be complete upon arrival to the Show.
- Entries must be completely set up by 9:45 am on Sunday, September 29, 2024.
- If the exhibitor is unable to deliver his/her entry, they may allow a designee, to place their entry on the table.
- The entry will be disqualified if, at the sole discretion of the Show, it is determined that the designee has altered the design in any manner.
- Entries should be designed to be viewed from all sides.
- Entries should feature 3 or more different plant species per container.
- Plant selection is at the exhibitor's discretion.
- Plants may belong to any species.
- Plants must be healthy, free of disease, and bug free.
- Plants are the only living items that may be included with the entry no other living items are permitted (e.g., animals, reptiles, bugs). Vivarium's are excluded from the competition.
- Plants should be clearly and attractively potted in a container that is suitable for tabletop display and able to be watered without leaks.
- Select a container that enhances the creative presentation of the entry.
- If submitting a container grown plant, double potting is permitted, provided natural top dressing is used and the inside of the container is not visible. Top dressing must not float when watered.
- If submitting a terrarium, double potting is not permitted.
- If submitting a terrarium, the container may be open air or closed.
- Leaf polish or other commercial foliage enhancers are not permitted.
- Accessories are permitted; however, emphasis should be on the creative use of natural, fresh planted materials rather than accessories to create a scene.

- Containers must fit on the table provided for display.
- Entries must not exceed a size of 30" Wide x 30" Deep.
- Entries may not exceed 50 lbs.

Delivery of Entries: Entries must be delivered to the Austin County Fair on Sunday, September 29, 2024, between 9 a.m. and 9: 45 a.m. Exhibitors must check in at each competition table that they have entered. Exhibitors will access the Austin County Fairgrounds through Gate 1 and 2 and park in front of the pavilion to unload.

Exhibitor Project Log: Each exhibitor must keep an Exhibitor Project Log that will be submitted the day of the competition at the check in table. Questions may be directed to the Horticulture Committee at <u>ACFHorticulture@gmail.com</u>

- Each exhibitor must maintain and submit a project log for each entry, using the Exhibitor Project Log available on the website at austincountyfair/menu/horticulture/project log.
- Other types of exhibitor logs will not be accepted. Entries without the approved ACF Exhibitor Project Log shown will be disqualified.
- The Exhibitor Project Log is assessed for content, not creativity and should include:
 - A brief narrative describing the source of inspiration for the entry and the steps taken during the creative process (e.g. selection and sourcing of plant materials).
 - A minimum of ten photographs taken during the cultivation of the entry.
 - Photographs must be printed and included with the log.
 - A list of plant materials used, including the genus, species, common name, cultivar or variety.
 - A timeline journaling/documenting the planting and maintenance activity.
 - ACF will not print logs for exhibitors. Project logs need to be complete, bound in a braded folder or binder with page protectors. No Paper Clips, No staples, or Pocket Folders. Project logs must be ready to be turned in when exhibitors arrive at the check-in table.

Judging: The Show will select qualified judges for each competitive event. Any questions about the judging criteria questions may be directed to the Horticulture committee at email address ACFHorticulture@gmail.com.

- Entries will be judged on the day of arrival.
- Entries will be judged on a 100-point system:
 - \circ Up to 40 points may be awarded for design.
 - Up to 35 points may be awarded for variety of plants used.
 - Up to 15 points may be awarded for staging and quality.
 - Up to 10 points may be awarded for the completion of Exhibitor Project Log.
- Judges may make notes in the Project Log.
- Only judges, Horticulture Committee members will be allowed inside the competition area while judging is in progress.
- Judges' decisions are final.
- Winning entries will be announced on September 29, 2024, and winning exhibitors will be recognized.

Any Container Plant placing 3^{rd} and on are encouraged to enter their Container plants into the 4H/FFA/FCCLA Junior or Senior or Open Youth Flower Show. Entry cards are available at the Expo Center on the day of entry. There is a power point online under Home Economics to help explain the entry procedure. There is a charge on \$3.00 per entry. Exhibits must not exceed 30" W x 30" D.

Prizes: Grand and Reserve Champion Container Plants will be awarded buckles for both Junior and Senior Divisions. Placement ribbons will be awarded to exhibitors placing 3rd thru 10th.

The Horticulture Committee will water the plants during the week. Pick up will be on Sunday, October 13, 2024 starting at 11 a.m.

SUPREME CONTAINER PLANTS

Supreme Champions will have the option to enter their Miniscape into the Youth Supreme & Country Auction to be held on Saturday, October 12, 2024.

Supreme Champions of the Container Plant Division will have the option to sell in the Youth Supreme & Country Auction and will receive the auction price minus the administrative fee from the fair. See the Youth Supreme & Country Auction section of this book for a full set of rules pertaining to the auction.

Youth Supreme Auction Sale Rules

Rules for entering individual contests vary, a complete set of rules and entry requirements per contest can be found online or in the Home Economics catalog. These rules are current as of publishing. Any updates will be posted on the Austin County Fair website. Please consult <u>www.austincountyfair.com</u> for any changes.

Eligibility

• All Exhibitors must be permanent residents in Austin County or be enrolled in a public school, private school or home

school in Austin County and not have graduated high school in order to Exhibit at the Austin County Fair.

- If an exhibitor Exhibits a project in an adjacent county fair within A Calendar Year of the Austin County Fair, then he/she is ineligible to show or sell another exhibit at the Austin County Fair. This does not include major shows.
- All entries are subject to the General Rules of the Austin County Fair
- All entries will be exhibited and sold by their owners unless he/she is physically unable to do so due to a medical condition. The ONLY permissible excuses for "physically unable to do so "are a DOCUMENTED medical or family emergency and /or a DOCUMENTED and sanctioned school function of which the exhibitor must PARTICIPATE. Exhibits to be shown or sold by someone else other than the owner must be approved in writing by the respective committee chairman. It is the responsibility of the exhibitor to obtain and complete the required form. Forms will be available at the Fair Office.
- If an exhibitor is Academically Ineligible to show, the exhibitor AND THEIR PROJECT are ineligible to participate in the Austin County Fair.
- Eligibility of Exhibitors earning Supreme will be verified by the specified District Adjunct Representative or Facility Representative. In the case of Open Youth Exhibitors, they will need to provide a copy of their current progress report.
- If an exhibitor is determined to be ineligible the exhibitor will forfeit their money and addons.
- Individual Items will be judged in their specific contest.

Thank You Notes & Checks

- Exhibitors will be required to submit a completed W-9 form for tax purposes.
- Items will be displayed in the designated area for Supreme entries.
- Items too large to be on display in the Expo building will be displayed via photos/videos during the sale.
- In the case where a committee provides materials for the contest the item will be started at that reserve amount to cover the cost for replacements at next year's fair.

- There will be a 7% fee deducted from the Exhibitors check for ACF accounting purposes.
- Handwritten "thank you" notes will be required for Buyers and for any additional add-ons provided. A list of thank you notes will be mailed to you by the fair.
- Checks will be distributed to Exhibitors when all checks are ready for distribution and upon receipt of a handwritten thank you note. Checks may only be picked up by the parent on the entry in accordance with the Austin County Fair Sale/Add-On Check policy.

In order to cash the Youth Supreme Auction checks, the EXHIBITOR must endorse the check. Exhibitors will have 30 days after checks are printed to turn in thank you notes and pick up checks. After this time period, the Sale and Add-On monies will go to the Austin County Fair Scholarship fund.

- Exhibitors participating as a team will receive a split check between team members of the amount received minus applicable fees.
- Participating in the Youth Supreme Auction Sale is highly encouraged but is not mandatory.
- Exhibitors will be allowed to sell in both the Youth Supreme & Country Auction (Saturday) and the Youth Livestock Sale (Friday).

- In the case of Baked Goods, items must be baked fresh in the specified quantities for the Auction on Saturday, Oct 12. Please deliver to the fairgrounds by 9 am to be sold as a whole item.
