The Fair will hold a photo contest for the cutest Lil' Wrangler. The contest is open to all babies and toddlers up to 3 years old and siblings!! So, moms, dads, grandparents, aunts, and uncles; dress up your Lil' Wrangler in western attire and start snapping those cameras. Your pictures can be taken either at the Lil' Wrangler Photo Center display on the stage by the 4-H hamburger stand. OR any western background of your choice.

- There will be four age Categories:
  0-6 months
  7-11 months
  12-23 months
  2-3 years old (must not be older than 3 by Sept. 1)
- 2) Siblings' Category. Can be any number of siblings of any age.
- 3) Pictures can be taken either at the Lil' Wrangler Photo display on the stage by the 4-H hamburger stand. OR any western background of your choice beginning Monday, September 8<sup>th</sup> and ending Saturday, September 27<sup>th</sup>. <u>NO professional photographers</u> <u>allowed</u>. Only one baby or toddler is allowed in each photo <u>except</u> in the Sibling category.
- Photos must not be larger than a 5x7. Photo and entry forms must be turned into the fair office by 5:00 p.m. on Monday, September 30<sup>th</sup> with a \$20.00 entry fee per photo. No entries accepted without fee. There will be no limit on photos entered.
- 5) The photos with the results will be displayed in the Exposition & Convention Center during the fair.
- 6) The photos and awards may be picked up at the Fair Office beginning Monday, October 13<sup>th</sup>. The awards not picked up by October 31, 2025, will be forfeited.
- 7) The winners in each age category will receive the following:
