The Fair will hold a photo contest for the cutest Lil' Wrangler. The contest is open to all babies and toddlers up to 3 years old. In addition, there is a NEW category for siblings!! So moms, dads, grandparents, aunts, and uncles; dress up your Lil'Wrangler in western attire and start snapping those cameras in the Lil' Red Barn on the fairgrounds located in the commercial building.

- 1) There will be four age categories:  
0-6 months  
7-11 months  
12-23 months  
2-3 years old (must not be older than 3 by Sept. 1)
- 2) Siblings category. Can be any number of siblings of any age.
- 3) Pictures must be taken in the commercial building at the fairgrounds between 10:00 a.m. and 7:00 p.m. beginning Saturday, September 14<sup>th</sup> and ending Sunday, September 29<sup>th</sup>. **NO professional photographers allowed.** Only one baby or toddler allowed in each photo except in Sibling category.
- 4) Photo must not be larger than a 5x7. Photo and entry forms must be turned into the fair office by 5:00 p.m. on Monday, September 30<sup>th</sup> with a \$15.00 entry fee **per photo.** **No entries accepted without fee.** There will be no limit on photos entered.
- 5) Photos with results will be displayed in the Exposition & Convention Center Wednesday October 9<sup>th</sup> until Sunday, October 13<sup>th</sup>.
- 6) Photos and awards may be picked up at the Fair Office beginning Monday, October 14<sup>th</sup>. Awards not picked up by October 21, 2019 will be forfeited.
- 7) The winners in each age category will receive the following:

**1<sup>st</sup> Place: \$75 & ribbon**

**2<sup>nd</sup> Place: \$50 & ribbon**

**3<sup>rd</sup> Place: \$25 & ribbon**
