2.Tax Collector, Susan Eggert, is requesting that if a tax payment is received, and the amount paid is over by \$2.00 or less, no refund will be issued. The overage will remain in the account and be given to the school district at the end of the tax year. Many other municipalities do this with a larger amount due to the cost of the stamp,envelope,and paper per each refund.

MOTION: To no longer refund a tax payment that paid over the amount due by \$2.00 or less. Any payment over \$2.00 will receive the refunded amount due.

3. Authorization to release the escrow account for the sidewalks to Muddy Paws Investments LLC, 3209 Oley Turnpike Rd. Reading, PA 19606 in the amount of \$15,712.50

MOTION: To approve the release of \$15,712.50 from the escrow account to Muddy Paws Investments LLC., 3209 Oley Turnpike Rd. Reading PA 19606 for the sidewalk installation which is complete and has passed all inspections.

4. Authorization to add an administration fee to permits- There are an increasing amount of permits, and with new residents moving in, more questions need to be answered and help with the paperwork. This takes time and the Borough does not see any money from the permits. Moving forward, as of October 1, an administration fee of \$25.00 be added to all UCC permits both Residential and Commercial.

5. Central Berks Police Department Contract Renewal 2025-2030

6. Truck Tailgate needs to be replaced, Roadcrew is requesting to upgrade the tailgate to put a lift in with it since it needs to be replaced now anyway.
