RESOLUTION 911-2025
SALE OF SURPLUS AND MATERIALS OF
MUNICIPAL PROPERTY

A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF ST. LAWRENCE, BERKS COUNTY, PENNSYLVANIA, IN ACCORDANCE WITH SECTION 1201.2 OF THE BOROUGH CODE AUTHORIZING THE SALE OR DISPOSAL OF MUNICIPAL PERSONAL PROPERTY WITH AN ESTIMATED FAIR MARKET VALUE OF TWO THOUSAND DOLLARS (\$2,000.00) OR LESS; AND AUTHORIZING SALE BY SEALED BIDS OR ELECTRONIC AUCTION AND ADVERTISEMENT FOR DISPOSAL OF SURPLUS MUNICIPAL PERSONAL PROPERTY WITH AN ESTIMATED FAIR MARKET VALUE IN EXCESS OF TWO THOUSAND DOLLARS (\$2,000.00)

WHEREAS, under Section 1201.1 of the Borough Code, 8 Pa.C.S.A. § 1201.1, the Borough shall have the authority to dispose of surplus personal property owned by the Municipality with a value of less than \$2,000 per item or lot by Resolution and in the manner most beneficial to the Municipality with the Council's prior approval.

WHEREAS, the same section of the Pennsylvania Borough Code also permits sale procedures including legal advertising when the Borough property to be sold has an estimated fair market value less than \$2,000 per item or lot so long as the Borough Council has adopted by resolution a procedure for such sale.


WHEREAS, The Borough Council has determined that it is in the best interests of the Borough to be able to advertise for sale by sealed bids, public auction, or electronic auction. Borough surplus equipment and materials valued above \$2,000 per item or lot.

WHEREAS, Borough Council now desires to permit the Borough of St. Lawrence to sell or dispose of unused, surplus, inoperable, or outdated Municipal personal property valued at less than \$2,000 without the need for legal advertising or formal, separate approval resolutions.

NOW, THEREFORE, BE IT RESOLVED this 9th day of January, 2025 by the Members of Council of the Borough of St. Lawrence that the Borough at its discretion is hereby authorized to sell or dispose of unused, surplus, inoperable or outdated Borough personal property valued at less than \$2,000 per item or lot.


AND BE IT FURTHER RESOLVED by the Members of Council of the Borough of St. Lawrence that the Borough Manager or designee is authorized to take steps to sell by sealed bids, at public auction, or electronic auction, including placement of required advertising in a newspaper of general circulation, unused, surplus, inoperable or outdated Borough personal property valued at more than \$2,000 per item or lot.


